	<p><u>DRAFT MATERNITY STRATEGY</u></p> <p>JS delivered a presentation on the above. The same presentation was presented to the NHS Board in September and a 3 month consultation period currently stands with comments to be sent to Joanne Sharp or Steven Sheach by the end of January.</p> <p>New Maternity Framework to be launched in the next couple of weeks.</p> <p>Vision Statement is – “Delivering Excellence in Maternity Care”.</p> <p>Discussion followed with the following being highlighted:</p> <ul style="list-style-type: none"> • LW raised the priority of addiction. • Action 8 under Addiction – potential for ADP to consider relevant issues. • KG - Helpful cross cutting themes across the Strategy. Drug misuse, teenage pregnancy; smoking in pregnancy. • National drivers supporting what has been done locally re smoking and alcohol use during pregnancy – none at all. • Child Protection issues also a factor in relation to babies staying in hospital longer. • KK – good timing in relation to maximising the CHP opportunity about overlap and what can be done in partnership. KK asked to share reporting and monitoring arrangements. Annual Report would be helpful to tie in with the Action Plans or SOA. • JS stressed that Ayrshire are good at recording figures which may account for our higher figures. • KG to tie in with Eddie in Relation to ADP. 1.	<u>HEALTH AND WELLBEING ACTION PLAN – CATHY ROARTY</u>	
	<ul style="list-style-type: none"> • Amendments need to be submitted by end of the month. KK Needs to finalise by next week. • Important to reflect relationship between adult services and children. • Good examples of Partnership activity is still ongoing, however, in light of budgets it is difficult to fully commit to actions. • Equalities group will scan all of the plans. • KK advised that an Equallies Health Group will be established to look at all 4 plans and to weed out all overlaps and to make it the best plan in relation to resources. 	

5.	ADHD PATHWAY	
	<p>JS gave a verbal update on this workstream. Good progress is being made. Good discussions at the group with parental participation.</p> <p>Aim of the pathway is to make life easier for children who are displaying certain behaviours and can see a route where they can be referred to and support provided.</p> <p>At the last group meeting a pathway was agreed and a booklet which has been developed by North Ayrshire to help and guide parents will be broaden to use across all Ayrshire. Feedback from parents in relation to the booklet is very positive.</p> <p>Next meeting will finalise the referral information and will be a single referral form. Not deviating from the GIRFEC/IAF model.</p> <p>Agreement to the pathway. Agreement Ayrshire Wide in trying to achieve the pathway and then need to look at implementation plan with schools and Primary Care.</p> <p>KG stressed the importance of bringing this back to a future meeting of the CHP to ensure that it is rolled out successfully through partnership working. JS to action. AS stated that feedback would need to be in January.</p> <p>JS asked if an Education Rep would like to sit on the Group. KG raised that she thought that Tom Williams was linking in with the group and it was established that he was invited but does not attend.
