

# grant assessment form

## 1 Aims and objectives of the organisation

Bellfield Youth Football Club promotes the sport of football for young males and females from the deprived areas of Bellfield and Shortlees within Kilmarnock. The club works with children and young people aged 5 to 15 years. The older team members benefit directly from regular sport, training and interaction with their peers which all acts as a positive youth diversionary measure and tackles social disorder problems by bringing young people together from these neighbouring communities. Our younger members are encouraged at an early stage to enjoy playing football and learn not only to be socially inclusive but also how healthy sporting activity coupled with sensible dietary promotion can enhance children's long term physical development.

The nucleus of our players live in areas designated as being of high social and economic deprivation. Our main objective is to provide healthy and enjoyable recreational pursuits for all our young people and give them as sense of identity and pride in the community plus offer friendship which all culminates in an improvement in the boys and girls quality of life.

## 2 Purpose of the grant (including breakdown of costs)

The grant will enable the club to do several things; firstly it will allow the replacement/upgrade of much needed equipment to improve the playing surface at the ground, including lawn mower and grass strimmer and it will assist the club to renew the flooring in the club house at Struthers, Scott Ellis, repair the guttering and down pipes and replace the existing alarm to the standard required by the insurance company. These improvements will improve health and safety conditions for the youngsters and coaching staff and by improving the playing surface the club will enhance coaching procedures with it resulting in team improvement in general fitness and health. Both of these improvements will benefit the existing age groups at the club plus our new under 7's boy's and girl's team. The pitch and club house upgrades which will allow the club to expand the use of the facility for the main secondary schools of both religious denominations at St. Joseph's and Grange Academy (these children come from all over Kilmarnock). The upgrades will hopefully be completed during the summer close of season and the measure of success of increased numbers of participants using the facility will be monitored and evaluated on a regular basis.

The club recently successfully applied to Awards for All for new football kits, training bibs, medical bags and training equipment but did not receive funding for our tractor, strimmer and flooring. They need the grant to complete this process of regeneration for the club and local area.

Lawn tractor for maintenance of playing surface - £5000

Professional strimmer for football pitch - £500

Fit clubhouse floor with plywood and heavy duty floor covering - £3500

Repair gutters and down pipes - £500

Replace existing alarm - £450
