

3. LOCAL GRANTS SCHEME 2009/10 - RING FENCED FUNDING

3.1 North West Environmental Improvements Group (CG 4541) (item 1 (b)(i), page 1105, 07/12) (pages 12-13) - The Central North Local grants Committee at its meeting on 31 March 2010 agreed to award, in principle, £925 subject to a condition of grant that the lease of transfer of ownership of the land of East Ayrshire Council to the organisation be confirmed in writing prior to any monies being released.

The Assessing Officer has since been advised that the group are no longer seeking to lease or own the land which they wish to improve by creating a footpath. It was therefore necessary to re-submit the application for grant funding to this Committee with an updated Officer's assessment ([copy enclosed](#)) recommending refusal.
