1 Aims and objectives of the organisation

To provide educational and social opportunities through play sessions for children aged 0-5 years, accompanied by their parents/carers, by:

- Holding group meetings – 1 session per week
- Having a programme of events which incorporates activities for all

2 Purpose of the grant (including breakdown of costs)

To assist with payment of hall lets of £7.50 per hour.

- 37 weeks x 1 session per week @ £15 = **£555** (August 2010 – June 2011)

To provide social excursions to a pantomime and an outing to Kidz Play.

- Pantomime = £70
- Kidz Play = £60

Total excursion costs = **£130**
