**1. PURPOSE OF REPORT**

- 1.1 To seek endorsement from the Community Health Partnership Forum for the 2009/10 Annual Review of the East Ayrshire Children and Young People's Services Plan 2008-2011.

**2. BACKGROUND**

- 2.1 Section 19 of the Children (Scotland) Act 1995 requires each local authority to prepare, publish and review a plan for the provision of relevant services in respect of children in their area, in partnership with key service providers.
- 2.2 In addition, the Plan requires to evidence consultation with the involvement of children and young people and their parents or carers.
- 2.3 The current Plan is the fourth full Children and Young People's Services Plan published within East Ayrshire.

**3. NATIONAL CONTEXT**

- 3.1 The former Scottish Executive's guidance to local authorities on the development of Children and Young People's Services Plans in November 2004 set out the overall aim of children's services planning taken from "*Partnership for Better Scotland: A Partnership Agreement*". This provided seven key outcomes often known as SHANARI for children and young people, namely:

- Safe
- Healthy
- Achieving
- Nurtured
- Active
- Respected and Responsible
- Included

- 3.2 In 2008 the vision for Scotland's children and young people was "rebadged" to become the foundation for the approach to promoting wellbeing in *Getting It Right For Every Child* which seeks to achieve the four capacities from the above outcomes:

- Successful learners
- Effective contributors
- Responsible citizens
- Confident individuals

**3.3** The advice, in recognition of the Scottish Ministers' strong commitment to the *Early Years Early Intervention Framework* and *Getting It Right For Every Child*, suggested local partners may wish to include information on local preparation and activities around these key policy areas.

## **4. THE LOCAL CONTEXT**

**4.1** Throughout the year young people's views are sought to influence the development of policy and planning. Routine consultation and engagement takes place through the undernoted:

- Children and Young Persons Forum
- Annual Youth Conference
- Dialogue Youth
- Student Councils
- Local Youth Forums
- Members of the Scottish Youth Parliament
- Residential Care Forum

**4.2** For some time now the Plan has been aligned with the East Ayrshire Community Plan and adopts the vision and principles of the Community Plan. Action Plans outlined in the East Ayrshire Children and Young People's Services Plan are grouped into four priority themes based on four of the six themes of the original Community Plan, prior to the changes to the Community Plan for 2009 onwards. These four themes were:

- Improving Community Safety
- Improving Health
- Improving Opportunities
- Promoting Community Learning

**4.3** Within an East Ayrshire context the overarching Community Plan remains central to planning and service activities, and more recently the Single Outcome Agreement has been developed across community planning partners.

**4.4** The Community Health Partnership arrangements are now in place and the implementation of the Children and Young People's Service Plan remains a key document to measure success in relation to improving outcomes for children and young people.

**4.5** The establishment of the new Community Health Partnership structure introduced Officer Locality Groups for Adults and Older People, and Children and Young People, of which the latter replaced the Children and Young People's Services Plan Steering Group as the main body for community planning partners to plan integrated services for the children and young people of East Ayrshire.

**4.6** The Officer Locality Group for Children and Young People has introduced new sub groups to reflect the current national policy drivers; to consider resource implications and to continue the alignment with the Community Plan. The following work streams and sub groups have been established:

- early years/early intervention;

- corporate parenting;
- promoting community safety;
- health and wellbeing;
- young people
- GIRFEC/IAF (Integrated Assessment Framework)

**4.7** The Children and Young People's Services Plan runs concurrently with the Child Protection Business Plan. Performance in relation to this therefore sits within the performance framework for that Plan. Members have previously received information in respect of the Her Majesty Inspectorate of Education report in the Joint Inspection of Services to Protect Children and Young People in the East Ayrshire Council area.

## **5. PERFORMANCE**

**5.1** Overall, performance against targets and indicators is very good.

**5.2** The full review is available on the Members Portal and at the Members Information Point. Attached to this report as an Appendix is performance data over the last three years which shows positive trends across most indicators.

**5.3** There remains significant challenges for all agencies to support children and young people achieve their full potential. The roll out of the Integrated Assessment Framework (IAF) commenced in 2009/10 and as of September this year, the Council and its partners are in full implementation phase, in the sense that training for processes and paperwork is complete. Officers are now focussed on the wider challenges in relation to practice change and developing the concept of the team around the child.

**5.4** The vast majority of targets set out in the original plan have been met with the exception of breastfeeding rates and teenage pregnancy. A separate breastfeeding action plan has been developed through the Community Health Partnership and the issue of rates of teenage pregnancy is being considered by the NHS Sexual health Strategy Group.

**5.5** The final year of the Plan will focus on:

- Further implementation of the Integrated Assessment Framework and associated practice change
- Continued focus on sustainable children and families social work services
- Implementing new kinship care procedures
- Progressing the refocused service design for children under 3 years of age
- Complete the review of short breaks for children with disabilities
- Concluding and implementing arrangements for further strengthening permanency planning
- Implementing the new Educational (Additional Support for Learning) Scotland Act 2009
- Monitoring the redesigned Child and Adolescent Mental Health Service to ensure improved service delivery
- Developing key actions for children and young people in the forthcoming drugs and alcohol strategy
- Implementation of the Breastfeeding Action Plan

## **6. FINANCIAL IMPLICATIONS**

- 6.1** Financial implications relating to specific service developments are subject to separate Cabinet approval and any future service specific developments which require Cabinet approval will be brought forward.

## **7. LEGAL AND POLICY IMPLICATIONS**

- 7.1** The statutory requirement, to publish and review Children's Services Plans is contained within Section 19 of the Children (Scotland) Act 1995.

## **8. COMMUNITY PLANNING IMPLICATIONS**

- 8.1** The proposals sit within the strategic context of East Ayrshire's Community Plan and as stated in paragraph 4.2 the Children and Young People's Services Plan is aligned to the Community Plan.

## **9. RISK MANAGEMENT**

- 9.1** The level of success in how well we meet the key objectives and actions set out in the Children and Young People's Services Plan relies on all partners working together and sharing a joint commitment to improve services for children and young people. There are robust planning arrangements in place to support integrated children's services planning.

## **10. RECOMMENDATIONS**

- 10.1** It is recommended that members of the Community Health Partnership Forum:
- (i) endorse East Ayrshire's 2009/10 Annual Review of the 2008-2011 East Ayrshire Children and Young People's Services Plan; and
  - (ii) otherwise note the content of the report.
