1. WELCOME

KG welcomed everyone to the meeting. She thanked Katie for all her work in the CHP and welcomed her back to EAC. Congratulated Tommy Burns in his new post as Health & Wellbeing Co-ordinator. She also welcomed Shiona Johnston to the meeting who is taking over the role of CHP Facilitator.

2. MINUTE OF LAST MEETING AND MATTERS ARISING (On Portal)

Note of meeting was agreed.

Item 1 – Budget setting timescales

Discussion at CHP Forum re budget consultation. Agreed at Forum that it would have information in relation to NHS A&A budget for 2011/12 and associated savings. KG then invited discussion at this meeting.

It was agreed that papers from NHS Ayrshire and Arran and East Ayrshire Council should be presented to the next meeting setting out budgetary information including potential implications for services; the potential impact on the delivery of partnership services and discussion on how we can work together.

3. PRESENTATION**Summary Update of the Child Dental Health Strategy Outcomes and Action Plan Developments between 2005-2010 –**

Ailsa Marrant Consultant in Dental Public Health

Delivered a presentation on the above. Areas highlighted were:

- *Dental health issues goes hand in hand with deprivation.*
- *Progress has been made but has fears about what lies ahead.*
- *Diet is crucial to the prevention of decay*
- *Increase resilience of teeth to decay i.e fluoride.*
- *2005-2009 figures showed an improvement of 10.7% in Scotland for 11/12 yr. olds decay free (permanent). Follow-up assessment will be done in 2011.*
- *2004-2008 figures showed an improvement of 7% in Scotland for 5 yr. olds decay free deciduous.*
- *2010 figures has showed a result of 62.7% = 10.7% improvement in NHS Ayrshire & Arran area.*
- *Tables showed from 2006 – 2010 that East Ayrshire has showed the greatest change in relation to children who have diseased dental issues.*
- *NHS A&A implemented Positive Partnerships and Community Development through Ayrshire. Multi-agency, multi-disciplinary pathway from birth to 12 years*
- *Tooth brushing programmes in place – 100% in nurseries and most schools*
- *Childsmile Practice in place.*
- *Pre5 child health surveillance programme in place*
- *Improved the number of dentists for NHS patients*
- *NHS 24 hours services also available*
- *55% of 0-2 years registered with a dentist*
- *80% 3-5 years registered in 2010 with a dentist.*
- *Various work ongoing i.e. Choose a Smile for Your Child*
- *embed completed actions and ensure monitoring and sustainability*
- *2005=10 strategic review*
- *New Strategy 2010-20 with action plan agreed with partners.*

KK asked what advice would be helpful in relation to the Community Plan and how best to align services?

- *Local targets will be set as won't be a national strategy. 5yr old target best as it will be an early indicator of how things are doing.*
- *Deprivation gap would be great but would be problematic to monitor.*
- *Fluoride application*
- *Hyperlink from the Community Plan into NHS Ayrshire & Arran strategies would be a possibility. KK to take forward with Shona Johnston.*

Improving Maternal and Infant Nutrition: A Framework –

Ruth Campbell, NHS Ayrshire & Arran

Ruth said that some of her presentation also linked into what Ailsa covered in her presentation.

Ruth talked the group through the attached presentation. Highlighted the following areas:

- Final Strategy was launched last week – not solely an NHS or breast feeding strategy.
- Action Plan for the Strategy – milestones and indicators. Dovetail with the Early Years Framework deliberately.
- Encouraging parents and children to change their eating behaviours
- Relates to Curriculum for Excellence
- Culture within which children find themselves requires to change to support breastfeeding and healthy eating through daily lives.
- Monitoring of children's weight and height
- Monitoring of mothers after birth (6-12months) re health would be an area for consideration to ensure maternal nutrition.

KG thanked RC and invited any questions.

- KK spoke about the breast feeding in relation to SOA and Community Plan. RC advised to keep it in both as it was a good indicator into other areas.
- KK said that discussions were in place regarding local targets.
- RC said that as this is not a national target it gives us an opportunity to shape our own targets. RC stressed that a consistency of approach from NHS Ayrshire & Arran must take place in relation to parents.
- Curriculum for Excellence – teachers are less comfortable with dealing with certain topics and this needs to be looked at to include breast feeding.

Stakeholder event will take place in March 2011.

3. DRAFT STANDARDS FOR INTEGRATED CARE PATHWAYS FOR CHILD AND ADOLESCENT MENTAL HEALTH SERVICES

AS took the group through the draft standards document which is available from the Portal. Invite is out to colleagues to be aware of and to comment on.

- Implementation hoped for March/April this year
- Link to get it out to wider groups to ensure the maximum feedback. AS said that it was well circulated and feedback just awaited and collated.

4. DRAFT OUTLINE FOR CHILDREN AND YOUNG PERSONS SERVICE (PORTAL) - KAY GILMOUR

DMcA took this item in KG's absence. Gave a brief outline of how the Plan will be formatted. Spoke of the key principles of the plan and how it ties in with the three frameworks - Early Years Framework, Equally Well and Achieving our Potential.

CR advised that SHANARI would be maintained. Separate Children and Young Person's Service Plan (changed to 4 yearly) which will dovetail with the Community Plan. Plan itself sets high level strategic planning which runs parallel to Community Plan. First drafts to be ready by end of February 2011. Following that consultation will follow through normal channels.

5. OUTCOME OF CONSULTATION WITH CHILDREN AND YOUNG PEOPLE ABOUT THE CHILDREN AND YOUNG PERSON SERVICES PLAN (PORTAL) - DOROTHY MCAVOY

DMcA spoke to the paper and highlighted that consultation with children and young people from 2 years to 21 years had taken place.

DMcA spoke of the recording through Voxur – will be distributed to group members in due course. Condensed into a 5 minute response from children and young people. DMcA spoke at length about responses received.

Highlighted findings – younger group of young carers (8-10) rated access to exercise as very low. Work needs to be done in this area.

Overall the priorities from children and young people remain consistent with priorities in the last Children and Young Person's Service Plan. Of 97 children who took the time to make a free text response 10% raised the issue of bullying. New Anti-Bullying Leaflets have now been placed onto GLOW website for access.

Mind maps and drawings were used for very young children.

Simpler version of the findings will be issued to children to ensure that they can understand the outcome of the consultation.

Question was asked about why specific questions were asked i.e. social work; child protection. DMcA advised that EAC wanted to know about their understanding of what these services do and how they can help them. .

EAST AYRSHIRE COUNCIL PROPOSED EFFICIENCY SAVINGS – POTENTIAL IMPACT ON THE PROTECTION OF CHILDREN - IAN SMITH

Issue raised in relation to the funding of the Child Protection post and the impact that this may have on inter-agency working. Highlighted also at the Child Protection Committee.

JL asked if background to this decision could be provided to OLG to give a better understanding where this has come from. It was hoped that the Changing Children's Service Fund would be able to maintain this post. However, this funding no longer exists.

KK stressed that there are changes in both organisation and things will need to be prioritised. Potential impact on joint outcomes and our ability to deliver.

The paper being brought to the next meeting should highlight potential impact.

This item will be a substantive item at the next meeting.

UPDATE ON INFANT MENTAL HEALTH

CR – Requested that she does an update on Infant Mental Health at next meeting.

NHS in Scotland have been working with Psychologist in mapping. EAC have been recognised for their work in this area including the Solihull Parenting Approach.

CR spoke about Incredible Years – really good robust evidence training programme for CAMHS. AS stated there is a model run in SAC which is non NHS A&A and runs in relation to CHAMS.

Agreed that CR to provide a paper to the next meeting.
