#### **DRAFT EAST AYRSHIRE COUNCIL MEETINGS CALENDAR FOR JANUARY TO DECEMBER 2011**

##### **Report by the Executive Director of Finance and Corporate Support**

#### **1. PURPOSE OF REPORT**

- 1.1** To submit for consideration of Council, a draft East Ayrshire Council Meetings Calendar for January to December 2011 (copy enclosed).

#### **2. BACKGROUND**

- 2.1** In terms of Standing Order 11, “Ordinary Meetings of the Council, Cabinet, Committees, Forums or Panels shall be held in accordance with the administrative arrangements approved by the Council from time to time”.
- 2.2** In line with current practice, the dates of public and school holidays have been taken into account in the preparation of the draft Meetings Calendar.
- 2.3** Information on the dates for Strathclyde Police Authority, Strathclyde Passenger Transport and South West Scotland Community Justice Authority meetings for 2011 are awaited, but will be inserted once received. Dates for COSLA and Strathclyde Fire and Rescue Board are included.
- 2.4** Dates of Local Community Planning Forums have not been included. The annual event in February 2011 will allow Members of the Forum to shape the Annual Work Plan for 2011 and decide on the format and frequency of Forum Meetings (i.e. joint Forums, day/evening/weekend, full or half day events). Once this process has taken place, suitable dates will be identified.
- 2.5** The dates for the Children & Young Person’s Forum have been inserted up until the Summer recess. Dates beyond this have not yet been set.
- 2.6** Dates for the Local Review Body have not been included. Meetings of the Local Review Body will be arranged as and when review requests are received.
- 2.7** Provisional dates for Appeals Panels have been scheduled in line with the new provisions as agreed at the Council meeting on 23 September 2010. If the meetings calendar is approved, arrangements will be made to populate, in advance, for a 3 month trial basis in the first instance, meetings with Elected Members include Substitutes.
- 2.8** Dates for Elected Member training seminars during 2011 have also been inserted. Topics for these seminars will be allocated in consultation with

appropriate Officers and Elected Members will be advised of these in early case along with approximate times.

**3. FINANCIAL/POLICY/COMMUNITY PLANNING IMPLICATIONS - Nil.**

**4. LEGAL AUTHORITY**

**4.1** In terms of the statutory meeting of Council, under Paragraph 1 of Schedule 7 of the Local Government (Scotland) Act 1973, as amended, a Council shall hold in every year such meetings as they think necessary and in an election year shall hold a meeting within 21 days from the date of the election.

**5. RECOMMENDATIONS**

**5.1** It is recommended to Council:-

- (i) to approve the enclosed Meetings Calendar subject to the inclusion of the meeting dates of the outside agencies identified at Paragraph 2.3;
- (ii) to note that dates for Local Community Planning Forum meetings will be inserted within the Meetings Calendar following the event in February 2011; and
- (iii) otherwise to note the contents of the report.
