DRAFT EAST AYRSHIRE COUNCIL MEETINGS CALENDAR FOR JANUARY TO DECEMBER 2010

Report by the Depute Chief Executive/Executive Director of Corporate Support

1. PURPOSE OF REPORT

- 1.1** To submit for consideration of Council, a draft East Ayrshire Council Meetings Calendar for January to December 2010 (copy enclosed).

2. BACKGROUND

- 2.1** In terms of Standing Order 11, "Ordinary Meetings of the Council, Cabinet, Committees, Forums or Panels shall be held in accordance with the administrative arrangements approved by the Council from time to time".
- 2.2** In line with current practice, the dates of public and school holidays have been taken into account in the preparation of the draft Meetings Calendar.
- 2.3** Information on the dates for the Strathclyde Police Authority, Strathclyde Fire and Rescue Board and CoSLA meetings for 2010 will be received mid-October. However, in the meantime dates for these meetings have been scheduled within the calendar based on the pattern from previous years. Dates for the Ayrshire Joint Planning and Steering Group are not yet available. For this and forthcoming years, it is also proposed to provide dates for the South West Scotland Community Justice Authority. Again, these dates are not yet available but will be inserted once received.
- 2.4** Dates of Local Community Planning Forums have not been included. The annual event in February 2010 will allow Members of the Forum to shape the Annual Work Plan for 2010 and decide on the format and frequency of Forum Meetings (i.e. joint Forums, day/evening/weekend, full or half day events). Once this process has taken place, suitable dates will be identified.
- 2.5** The dates for the Children & Young Person's Forum have been inserted up until the Summer recess. Dates beyond this have not yet been set.
- 2.6** Dates for the new Local Review Bodies have not been included. A separate meetings cycle will be prepared and will, as far as possible, take cognisance of Members commitments in respect of the attached draft Meetings Calendar.

3. FINANCIAL/POLICY/COMMUNITY PLANNING IMPLICATIONS - Nil.

4. LEGAL AUTHORITY

4.1 In terms of the statutory meeting of Council, under Paragraph 1 of Schedule 7 of the Local Government (Scotland) Act 1973, as amended, a Council shall hold in every year such meetings as they think necessary and in an election year shall hold a meeting within 21 days from the date of the election.

5. RECOMMENDATIONS

5.1 It is recommended to Council:-

- (i) to approve the enclosed Meetings Calendar subject to the inclusion of the meeting dates of the outside agencies identified at Paragraph 2.3; and
- (ii) to note that dates for Local Community Planning Forum meetings will be inserted within the Meetings Calendar following the event in February 2010; and
- (iii) otherwise to note the contents of the report.
