WORK PROGRAMME: QUARTERLY UPDATE

Report by Depute Chief Executive/Executive Director of Corporate Support

1. PURPOSE OF REPORT

- 1.1 The purpose of this report is to provide a quarterly update of the Governance and Scrutiny Committee's Work Programme.

2. BACKGROUND

- 2.1 The Committee have agreed to receive quarterly update reports on the three key elements of its work as follows:-

- Element 1 which consists of regular monitoring reports which provide information to Members to determine future reviews or for further analysis at meetings of the Committee (See Appendix I). Reports have been categorised into the main functions of the Committee namely:-
 - Audit & Risk;
 - Corporate Governance;
 - Performance and Best Value;
 - Scrutiny; and
 - General;
- Element 2 which will provide full scrutiny/review exercises covering a range of topics determined by the Committee, in accordance with the approved Governance and Scrutiny Guidelines. The topics selected for review in 2008/09 are as undernoted and the position in respect of the Work Programme relative to each topic is as indicated, namely:-
 - Topic 1 - to ascertain the availability of affordable housing throughout the settlements of East Ayrshire - Members of the Committee have previously agreed that progress on work in relation to the preparation of the new Local Housing Strategy and Local Development Plan be kept under review and a report on this topic submitted to Committee in February/ March 2009 for consideration;
 - Topic 2 - to explore the background reasons for the level of complaints on contract upgrades to the Council's housing stock within the Capital Programme - work is currently ongoing to update the Review Programme relative to this topic having regard to the views expressed by members of the Committee arising from the awareness raising presentation by the Executive Head of Finance and Asset Management, and it is intended that the revised Programme will be submitted to the next meeting of the Committee for consideration; and

- Topic 3 - the Vehicle Tracker System (Masternaut Traffic Management System) - the updated Review Programme for this topic is provided at Appendix II.
- Element 3 which consists of the call-in process to provide for regular review of Cabinet decisions (See Appendix III).

3. FINANCIAL/LEGAL/POLICY/COMMUNITY PLANNING IMPLICATIONS - Nil.

4. FUTURE UPDATES

- 4.1** Given that the Committee's working arrangements have now been well established and Members have become familiar with these, it is proposed that future updates in respect of the Committee's topic review/scrutiny work be provided on an ad hoc basis, as and when required, rather than on a fixed quarterly basis. In addition, the general business/monitoring schedule which features in Appendix I and the summary of call in business, as featured in Appendix II to this report, will be retained by Officers as an administrative tool to ensure the accurate tracking of business being dealt with by the Committee.

- (i) note the quarterly update report of work programme, and
- (ii) agree that future updates on the Committee's work be submitted on an ad hoc basis as set out in paragraph 4.1, above.
