1 Aims and objectives of the organisation

To cultivate the arts of music & drama, to promote public appreciation of the Arts, to give at least one public performance per year and to assist charitable organisations

2 Purpose of the grant (including breakdown of costs)

The Grant would be used to defray some of the production costs for this year's show "Crazy for You". For the first time in the Society's 70+ year history they are experiencing very poor ticket sales. Steps have been taken to reduce costs where possible. A grant is sought to help KAOS to break even financially and ensure that KAOS survives to stage shows and concerts in future years.

4 How will the grant :-

(a) develop the organisation; or

It will allow the organisation to continue to provide participation in the arts for its members. It will allow new members the opportunity to perform on a professional stage for the first time and therefore encourage their personal development.

(b) benefit the local community.

Over 2,000 ticket holders will benefit from enjoying a great Musical and being allowed the chance to actively attend a local arts event. The Palace Theatre will benefit from attracting over 2,000 patrons into the venue in one week and capturing their data information for future use. EAC will benefit by ensuring a diverse mix of participatory arts events throughout the region as KAOS provide that opportunity to local people.

The survival of KAOS will allow the Concert Party to continue to perform at nursing homes, churches etc throughout the year across the whole of East Ayrshire and take music to individuals who would not otherwise be able to access such services. KAOS have also a long history of supporting charity and each year donate approx £3,000 from audience collections to nominated charities. This will cease to happen if KAOS is unable to survive.

KAOS have a long history of producing high quality musical shows at the Palace Theatre and it would be a detriment to the Palace programme to lose this local element. The show will deliver its aim of attracting over 2,000 people to the Palace Theatre and providing great entertainment but it requires financial assistance to ensure its continued success. The company have proven their commitment to securing their future by working with EAC and the Palace Theatre to investigate future funding avenues and marketing support. It is recommended that a contribution of £1000 is awarded, recognising that the group has a substantial sum set aside for contingency. A condition of any award should be that an up to date bank statement is provided by the group.
