M77 SLIP ROADS/EMERGENCY ACCESS

Report By Executive Director of Development & Property Services

1. PURPOSE OF REPORT

- 1.1 The purpose of the report is to advise the Forum on the implications for emergency access to the M77 if the south-facing slip roads at the Kingswell junction are not constructed.

2. BACKGROUND

- 2.1 The south-facing slip roads at the Kingswell junction on the new M77 would allow northbound M77 traffic to exit the motorway and southbound local traffic to join the motorway. However, despite intensive lobbying by East Ayrshire Council, the Scottish Executive do not consider these slip roads to be essential for the interchange arrangements for local and M77 traffic at Kingswell. The slip roads may be provided by the developer of the proposed Motorway Service area (MSA) subject to agreement being reached with the Scottish Executive, but if the MSA development does not go ahead, these slip roads will not be built. The slip roads are not included in the current construction contract.
- 2.2 At the last meeting of the Forum on 22 September 2004 the Northern Area Local Committee representative raised that Committee's concerns about the implications for emergency vehicle access to the M77 if the south-facing slip roads at Kingswell are not provided.

3. THE SCOTTISH EXECUTIVE'S RESPONSE

- 3.1 Following similar concerns raised by the Ayrshire Economic Forum, the Head of Roads & Transportation wrote to East Renfrewshire Council, (the Project Director for the scheme) and the Scottish Executive on 15 July 2004.
- 3.2 The responses made it quite clear that the motorway has been designed in accordance with current guidelines. The emergency services were consulted and the issue of journey times for emergency response fully discussed with the relevant parties. No adverse comments were received.
- 3.3 Copies of this correspondence are attached to this report (Appendix 1).

M77/GSO PROJECT - KINGSWELL INTERCHANGE

I have received correspondence from the Ayrshire Economic Forum following their meeting of 11 June 2004 expressing their concerns over the deletion of the south facing slip roads at the Kingswell Interchange.

I have been asked to pass these concerns to yourself as Project Director for the scheme and to the Scottish Executive.

Their concerns relate mainly to journey times of emergency vehicles attending incidents on the M77 between Fenwick and Malletsheugh.

It is understood that for safety reasons the emergency cross overs on the motorway will be closed off with safety fence, as a result, without the south facing slip roads, emergency vehicles could be involved in a considerable journey to the first available exit, resulting in poorer response times.

The Forum are aware that the missing slip roads at Kingswell may be provided by the developer of the proposed Motorway Service Area subject to agreement being reached with the Scottish Executive but should negotiations collapse, these slip roads will not be built.

Could you please provide a response to these concerns to enable me to reply to the Ayrshire Economic Forum.


As you may know, the Economic Forum's letter to you followed the presentation by Kingswell Developments to the Forum on 11th June at which Kingswell Developments raised the issue. This is the third time this issue has been raised with the Executive in recent weeks - each time courtesy of Kingswell Developments.

The design of the M77 has been through due process - as has that for the Glasgow Southern Orbital - with all the consultation process that implies. The junction spacing on the M77 do not appear excessive - indeed our concerns have been for the close spacing of junctions at the southern end requiring departures from standards.

The Executive has received no adverse comments from the emergency services on the design of the M77 between Fenwick and Malletsheugh that I have been able to trace.

If you are aware of anyone at the emergency services who is pressing this issue please let me know.
