#### **ABSENCE MANAGEMENT REPORT QUARTER 2 (July 2006 – September 2006)**

##### **Report by Executive Director of Neighbourhood Services**

#### **1. PURPOSE OF REPORT**

- 1.1 The purpose of this report is to advise the Committee of absence rates for Community Services, within the Department of Neighbourhood Services, for the quarterly period ending 30 September 2006.

#### **2. HISTORICAL INFORMATION**

- 2.1 Historical data for this quarter is detailed in Appendix A to assist members in considering the absence rates.

#### **3. ANALYSIS OF QUARTERLY ABSENCE RATES**

- 3.1 The Department's average absence rates over the period 1 July 2006 – 30 September 2006 was 4.63% for APT&C employees and 6.63% for Manual workers. This compares to 3.85% for APT&C employees and 5.02% for Manual Workers in the same quarter in 2005.

#### **4. DIRECTOR'S COMMENTS**

- 4.1 With regard to the absence levels reported for Quarter 3 the following can be noted:
  - 4.1.1 Other reason was the main reason for absence within Community Services, accounting for 14.77% of the overall collective absence rate. The other main reasons for absence included Musculo Skeletal which accounted for 14.6% and Operations/Recovery at 11.93%.
  - 4.1.2 20 Absence Reviews and 61 Follow-Up Meetings were held in Community Services. There was 21 medical referrals to the Occupational Health Service and 2 welfare referrals.
  - 4.1.3 A detailed review of individual record cards within each section has been carried out to ensure that the Council's Managing Absence Policy is being adhered to in terms of Absence Review Meetings.

## **5. FINANCIAL IMPLICATIONS – COST OF ABSENCE**

- 5.1 The current cost of absence requires to be met from within existing resources.
- 5.2 The Head of Personnel continues to review the Council's existing Managing Absence Policy with a view to further reducing absence levels and related costs.

## **6. LEGAL/POLICY IMPLICATIONS**

- 6.1 Absenteeism within Community Services is being managed in accordance with the Council Policy and employment legislation.

## **7. RECOMMENDATIONS**

- 7.1 The Community Services Committee is asked to note the contents of this report.
