#### **STREET NAMING: PROPOSED HOUSING DEVELOPMENT LOCATED OFF AUCHINLECK ROAD, CUMNOCK**

#### **Report by the Depute Chief Executive/Executive Director of Corporate Support**

#### **1. PURPOSE OF REPORT**

- 1.1** To request the Committee to consider and determine a name for the new street to be created by a private housing development located off Auchinleck Road, Cumnock.

#### **2. BACKGROUND**

- 2.1** The Decentralisation Sub-Committee of the Policy and Resources Committee at its meeting on 4 June 1996, agreed that the naming of streets be included within the remit of Local Committees.
- 2.2** Section 97 of the Civic Government (Scotland) Act 1982, gives authority to East Ayrshire Council in relation to the naming of streets and the preparation of house numbers etc.
- 2.3** The normal practice for the naming of streets is for the local Community Council to be invited to liaise with the local Elected Member and to submit a suggestion or suggestions for consideration by the Local Committee.

#### **3. CURRENT POSITION**

- 3.1** Cumnock Community Council has suggested that the street be named "Terrinzean View", as there is a view of Terrinzean Castle from the development site. Councillor William Crawford, being the Local Elected Member, is happy with this suggestion.

#### **4. FINANCIAL IMPLICATIONS**

- 4.1** The cost of providing street signs at this development will be met from existing budgets.

#### **5. RISK MANAGEMENT IMPLICATIONS**

- 5.1** Failure to allocate a street name to this development timeously may result in difficulties arising from a delay in determining addresses for the houses to be constructed.

#### **6. LEGAL/POLICY IMPLICATIONS - NIL**

## **7. RECOMMENDATIONS**

### **7.1** It is recommended:-

- (i) that the Committee name the proposed new street located off Auchinleck Road, Cumnock; and
