

EAST AYRSHIRE CHILDREN'S PANEL - EXTENSION OF CONCURRENT MEMBERSHIP SCHEME WITH NORTH AYRSHIRE CHILDREN'S PANEL (pages 1-4)** - Submit report dated 26 February 2007 (copy enclosed) by the Depute Chief Executive/Executive Director of Corporate Support seeking approval for a further extension to the concurrent membership scheme with North Ayrshire Children's Panel for the period up to and including 31 May 2008, in order to populate East Ayrshire Children's Panel with male Panel Members.
