ABSENCE MANAGEMENT REPORT QUARTER 3 (2006) FOR HOUSING & BUILDING AND WORKS SERVICES

Report by the Executive Director of Neighbourhood Services

1. PURPOSE OF REPORT

- 1.1 The purpose of this report is to advise the Committee of absence rates for the Housing and Building & Works Services within the Department of Neighbourhood Services for the quarterly period ending 30 September 2006.

2. HISTORICAL INFORMATION

- 2.1 Historical data for this quarter is detailed in Appendix A to assist members in considering the absence rates.

3. ANALYSIS OF QUARTERLY ABSENCE RATES

- 3.1 The average absence rates for the Housing and Building & Works Services over the period 1 July 2006 - 30 September 2006 are as follows:

4. DIRECTOR'S COMMENTS

- 4.1 With regard to the absence levels reported for Quarter 3 the following can be noted:

- 4.1.1 Short term absence was the main reason for absence within the Housing & Building & Works Services of the Department of Neighbourhood Services, accounting for 3.13% of the overall collective absence rate.

- 4.1.2 36 Absence Reviews and 25 Follow-Up Meetings were held in the Housing & Building & Works Services within the Department of Neighbourhood Services. There were 6 referrals to the Occupational Health Service and 12 referrals for physiotherapy.

4.1.3 A detailed review of individual record cards within each section has been carried out to ensure that the Council's Managing Absence Policy is being adhered to in terms of Absence Review Meetings.

5. FINANCIAL IMPLICATIONS – COST OF ABSENCE

5.1 The current cost of absence requires to be met from within existing resources.

5.2 The Head of Personnel continues to review the Council's existing Managing Absence Policy with a view to further reducing absence levels and related costs.

6. LEGAL/POLICY IMPLICATIONS

6.1 Absenteeism within Neighbourhood Services is being managed in accordance with Council Policy and employment legislation.

7. RECOMMENDATIONS
