#### **ANNUAL SEMINAR FOR COMMUNITY REPRESENTATIVES**

##### **Report by Annual Seminar Working Group**

#### **1. PURPOSE OF REPORT**

- 1.1** The purpose of the report is to advise the Local Committee of the outcome of the Annual Seminar for Community Representatives held on 11 November 2006.

#### **2. BACKGROUND**

- 2.1** The Decentralisation Sub-Committee at its meeting held on 24 September 1998 (Item 2, Page 3875, 96/99) agreed to progress with arrangements proposed by the Working Group for the Annual Seminar as part of the Council's commitment to continual improvement within the Decentralisation Scheme.
- 2.2** The main purpose of the Seminar was to provide a Forum for Community Representatives to exchange best practice ideas on Local Committee processes, identify personal development needs and comment on the Decentralisation Scheme insofar as it affected Local Committees.

#### **3. 2006 ANNUAL SEMINAR**

- 3.1** Following on from the success of the 2005 Annual Seminar, the Working Group agreed that the 2006 seminar would focus on informing Community Representatives and Substitutes of East Ayrshire's Community Plan.
- 3.2** It was therefore, agreed to hold the Annual Seminar on Saturday 11 November 2006 in the Council Headquarters, London Road, Kilmarnock between 10.00 am and 2.00 pm.
- 3.3** The Seminar began with a presentation by the Chief Executive on the successes of the Community Plan to date, and which gave an overview of the Community Plan's focus for future action.
- 3.4** Three workshops were held during the Seminar, each focusing on two of the six main themes of the Community Plan. The workshops were facilitated by Community Workers from the Council's Community Learning and Development Section who were supported by the Lead Officer for the relevant theme or their representative (as referred to in Appendix II).

**3.5** Thereafter, the Community Representatives and Substitutes had the opportunity to participate in an open question and answer session, involving the Chair of Community Planning, the Depute Chief Executive/Executive Director of Corporate Support, Superintendent Liz Weir, Strathclyde Police and the Lead Officers or representatives as referred to in Paragraph 3.4.

**3.6** The evaluation results from the Seminar are enclosed under Appendix 1. It can be seen from the evaluation responses that the Seminar was an overwhelming success with those attending finding it beneficial.

## APPENDIX 2

### **COMMUNITY REPRESENTATIVES SEMINAR: SATURDAY 11 NOVEMBER 2006**

#### **Workshop A - Themes: Improving Opportunities and Promoting Community Learning**

##### **Improving Opportunities - Robert Paton, Head of Economic Development**

- The Community Representatives felt that Education needs to be developed for all ages, particularly vulnerable adults.
- The Community Representatives were of the view that alternative education would be more beneficial, the focus to reach all needs rather than the schools traditional curriculum. It was recommended that alternative education would consist and focus on raising the awareness and importance of work experience. It was decided that this should be a large part of the school programme, raising confidence and preparing the young people for work and reaching those that do not enjoy the academic curriculum.
- It was suggested that additional training for 'old trades' was significant. The skills of 'old trades' such as, plumbing and joinery are valuable and there was a fear of them dying out. Therefore, it was recognised that they must be passed on with the main focus / priority to young people.
- How do you work with areas that have very little facilities and services for employment opportunities?
- What opportunities are there and what has been done in the Irvine Valley Area?

##### **Promoting Community Learning - Janice Harrison, Team Leader**

- Some of the Community Representatives questioned whether young people were participating in the Outreach Project and whether the programme was active. The general opinion was that some of the young people who attend were referred from other Agencies and participate through a set programme.
- The Community Representatives requested figures of the attendance for the Outreach Project and other Youth Clubs.
- The Community Representatives felt that it was the same young people attending the clubs.
- The Community Representatives were impressed with the determination and commitment of Voluntary Organisations.

- The Community Representatives commented that Community Learning & Development should make strong links with Voluntary Organisations, supporting and helping with their finances.
- The Community Representatives questioned whether young people were more likely to attend Voluntary Organisations than ones run by local authorities.
- With regard to the weightlifting project, the Community Representative's praised the success of the Project and recommended that there should be more like it. The Community Representatives felt that money and funding should be used more creatively and imaginatively.
- How and what had been done to target those with very low self esteem? How does Community Learning reach and make contact with those that are most disadvantaged?
- How to tackle those not interested in education?
- Have those in the past that never attended school missed out on initiatives.
- What opportunities are available for the elderly generation?
- Why are young people still not taking part in opportunities provided? e.g. Youth Clubs with low attendance numbers.
- What research has been done to illustrate why the programmes are not attracting all young people?
- If there is research, then what evidence is there?
- Money should be spent on the research rather than spent on programmes that do not bring in the numbers.
- It was queried whether there was a theme/trend emerging of why low attendance.
- The matter was raised that not all young people could access workshops or have a wide range of employment due to public transport.
- The Community Representatives commented that it is not always clear where to access future funding. It was agreed that a list of all the available funding must be created.
- It was also suggested that for new groups that are starting up there should be more opportunities and support required e.g. free access or lets to facilities until the group has been established.

- It was agreed that the Community Partnerships should be expanded and that Community Learning & Development and Improving Opportunities must link closely together.
- Peer Education was discussed, relating back to the Outreach programmes, explaining that young people should go out on the streets interacting and reaching to the needs of their peers.

## **Workshop B - Themes: Improving Health and Improving Community Safety**

### **Improving Health: Cathy Roarty, NHS Ayrshire and Arran**

- It was encouraging to see collaborative working between East Ayrshire Council and NHS Ayrshire and Arran. There is still a need for more, especially at the community level.
- Need to follow up work with alcohol and drugs, safety net required. Identify lead roles.
- Food initiatives required, salt intake, sugar etc also looking at the bigger picture with food. Healthy eating/cooking and additives.
- Shared services, police, health services, social services, education and environmental services. Need for more communication with each other.

### **Improving Community Safety: Anne Williams, Community Safety Officer**

- Who will pay for more services i.e. community safety awareness?
- People feeling venerable in their homes, afraid to go out at night, afraid to report incidents.
- Introduce on spot fines - give power to community wardens.
- Spot fines for litter, dog fouling and drinking alcohol on the street.
- No cycling on pavements requires action now.
- Bins obstructing pavements after emptying – require bins to be put back in place.
- Police presence in Kilmarnock town centre at weekend welcomed as well as taxi rank marshals. Police also required in suburbs at weekend. Will this initiative be set up in Cumnock?
- More people are seeing youth drinking on streets and parks. Enforce the laws on drinking. Introduce age card, heavy fines for adults supplying or buying alcohol for under age youths.

## **Workshop C - Themes: Eliminating Poverty and Improving The Environment**

### **Eliminating Poverty: Jackie Donnelly, Executive Head of Social Work**

- Housing is essential to an Anti-Poverty agenda. Resources are taken away from Local Authority to Housing Associations. Is this a good idea?
- White meter heating is expensive and, on reduced incomes, very difficult to manage successfully in cold months.
- Local Plan: Resources need to be set aside for affordable housing.
- Registration of social landlords. How helpful will this be?
- Local Authority should press for the buying back of social housing and at the price it was originally sold at.
- Fuel poverty - grant for changing fuel needs clarification very confusing; Need specialist advisors on use of fuel; and expense of getting fuel access to housing stock.
- What debt counselling is happening in schools at this time?
- Credit Union in Shortlees? What plans?
- Shopmobility – Opened on 17<sup>th</sup> August in Kilmarnock Town Centre. Is this for anyone with mobility problems?.

### **Improving the Environment: Karl Doroszenko, Policy and Project Manager**

- New Cumnock Town Hall needs improvement.
- Community Action Plans - Local Communities want to be involved in developing what they want seen and accomplished in their Communities.
- When are improvements coming to Shortlees and Kilmarnock and Loudoun areas?
- Woodland Group - needs more money. This has been an excellent piece of work.
- Property Developers are causing problems with Communities - if they are moving into communities they need to support and improve leisure/recreational facilities. Council should pre-think before planning agreed.
- A clear focus on agreements with planning and Community – keeping the balance is important so investment comes to East Ayrshire Council.

- What are the development plans for Southcraigs?
- Core Paths Plan a good thing. Any chance of this being expanded? Note - Chips not relevant for walking.
- Long running projects ie old opera house Howard Park area – nothing happening. Any developments for this site?.
- Kay Park Monument – are we any further forward?
- Problems with information on these issues for local communities.
- Local Authorities, especially East Ayrshire, does not do enough public relations on what it does do.
- Legislation is changing rapidly – prohibits compulsive purchase – 4 years to do.
- Can we learn lessons from the Dean Visitor Centre Success?
- Burns - this is an important focus for visitor attraction to Kilmarnock. Council need to address.
- Dean Castle links to Kay Park. Seem to have been left aside.
