#### **MEETINGS OF KILMARNOCK NORTH LOCAL COMMITTEE: PERIOD UNTIL 24 MAY 2007**

#### **Report by Depute Chief Executive/Executive Director of Corporate Support**

#### **1. PURPOSE OF REPORT**

- 1.1** To advise of the date in which meetings of the Local Committee are scheduled to take place during the period until 24 May 2007 and to invite the Committee to determine the venues at which each of these meetings should be held.

#### **2. BACKGROUND**

- 2.1** East Ayrshire Council at its meeting held on 12 October 2006, approved the Calendar of Committee Meetings for the period until 24 May 2007. The Calendar includes dates for the meetings of each Local Committee.
- 2.2** Determination of the venues at which Local Committee meetings are to be held at this stage will generally assist Members, Community Representatives and Officers in planning their diaries and will greatly facilitate arrangements for booking the venues concerned.

#### **3. ACCOMMODATION AVAILABLE**

- 3.1** The undernoted premises in each of the Communities within the Local Committee Area contain suitable accommodation for meetings of the Committee, namely:-
- (a) Onthank Community Education Centre; and
  - (b) New Farm Loch Community Centre.

- 4.1** During the period January 2006 to December 2006, meetings of the Local Committee took place on the dates and at the venues undernoted, as follows, namely:-

Tuesday 21 March 2006 - Onthank Community Education Centre;  
Tuesday 23 May 2006 - New Farm Loch Community Centre;  
Tuesday 12 September 2006 - Onthank Community Education Centre; and  
Tuesday 7 November 2006 - New Farm Loch Community Centre.

## **5. MEETINGS PROGRAMME FOR PERIOD TO 24 MAY 2007**

**5.1** The dates fixed for the meetings of the Kilmarnock North Local Committee for the period until 24 May 2007, together with suggested venues are as follows, namely:-

Tuesday 30 January 2007 - Onthank Community Education Centre; and  
Tuesday 20 March 2007 - New Farm Loch Community Centre.

**5.2** The venues above are suggested as being suitable in terms of the likely availability and physical size and layout while at the same time an effort has been made to ensure that the practice for holding meetings at venues throughout the Committees area is continued, having with regard to the venues at which recent meetings have been held is detailed in Section 4 and the venues available at Section 3 above.
