#### **NAMING OF STREETS BY LOCAL COMMITTEES – PROPOSED NEW HOUSING DEVELOPMENT OFF AYR ROAD, KILMARNOCK**

##### **Report by the Depute Chief Executive/Executive Director of Corporate Support**

#### **1. PURPOSE OF REPORT**

- 1.1 To request the Committee to consider names for a street at a new housing development off Ayr Road, Kilmarnock.

#### **2. BACKGROUND**

- 2.1 The Decentralisation Sub-Committee of the Policy and Resources Committee, at its meeting on 4 June 1996, agreed that the naming of streets be included within the remit of Local Committees.
- 2.2 Section 97 of the Civic Government (Scotland) Act 1982 gives authority to East Ayrshire Council in relation to naming of streets and the preparation of house numbers etc.
- 2.3 The Local Member, Councillor Ray Murray, has been informed of the development and requested to put forward suggestions on the name for the street to this Committee.
- 2.4 The normal procedure would also be to consult the Local Community Council. In this instance, however, Shortlees Community Council will be re-established at a future date.
- 2.5 In the circumstances, Councillor Murray has requested that Community Representatives and Substitutes be invited to make suggestions for naming the development.

#### **3. CURRENT POSITION**

- 3.1 Councillor Ray Murray has suggested Caprington Court.
- 3.2 Community Representative John Timpany has suggested Darnbrough Street.
- 3.3 Community Representative Joan Wark has suggested Craigie View.

#### **5. RECOMMENDATIONS**

- 5.1 It is recommended:-
- (i) that the Committee name the street at the new development off Ayr Road, Kilmarnock;
