MEETINGS OF NORTHERN AREA LOCAL COMMITTEE: PERIOD UNTIL 31 DECEMBER 2005

1. PURPOSE OF REPORT

- 1.1 The purpose of the report is to advise of the dates on which meetings of the Local Committee are scheduled to take place, and to invite the Committee to determine the venues at which each of these meetings should be held.

2. BACKGROUND

- 2.1 East Ayrshire Council, at its meeting held on 14 October 2004, approved the calendar of Committee meetings for the period until 31 December 2005. The calendar includes dates for the meetings of each Local Committee.
- 2.2 Determination of the venues at which Local Committee meetings are to be held at this stage will generally assist Members, Community Representatives and Officers in planning their diaries and will greatly facilitate arrangements for booking of the venues concerned.

3. ACCOMMODATION AVAILABLE

- 3.1 The undernoted premises in each of the communities within the Local Committee's area contain suitable accommodation for meetings of the Committee, namely:-
- (a) Dunlop Public Hall;
 - (b) Kilmaurs Community Centre;
 - (c) Stewarton Annick Youth and Community Centre; and
 - (d) John Fulton Hall, Fenwick

4. DATES AND VENUES FOR PERIOD JANUARY 2004 TO OCTOBER 2004

- 4.1 During the period January 2004 to October 2004 meetings of the Local Committee took place on the dates and at the venues, as follows, namely:-
- 15 January 2004 – Dunlop Public Hall;
 - 11 March 2004 – Kilmaurs Community Centre;
 - 6 May 2004 – Stewarton Annick Youth and Community Centre;
 - 26 August 2004 – John Fulton Hall, Fenwick; and
 - 28 October 2004 – Dunlop Public Hall.

5. MEETINGS PROGRAMME FOR PERIOD TO 31 DECEMBER 2005

- 5.1** The proposed dates fixed for the meetings of the Northern Area Local Committee for the period until 31 December 2005, together with suggested venues are as follows, namely:-

Thursday 13 January 2005 – Stewarton Annick Youth and Community Centre
Thursday 10 March 2005 – John Fulton Hall, Fenwick
Wednesday 4 May 2005 - Kilmaurs Community Centre
Thursday 25 August 2005 – Dunlop Public Hall
Thursday 27 October 2005 – Stewarton Annick Youth and Community Centre

- 5.2** The venues above are suggested as being suitable in terms of likely availability and physical size and layout whilst at the same time an effort has been made to ensure that the practice of holding meetings at venues throughout the Committee's area is continued, having regard to the venues at which recent meetings have been held as detailed in Section 4 above.
