1. PURPOSE OF REPORT

- 1.1 To advise the Local Committee on the outcome of recruitment for the Community Representative/Substitutes to serve on the Northern Area Local Committee for the period 1 April 2004 to 31 March 2005.

2. BACKGROUND

- 2.1 The Council's Decentralisation Scheme makes provision for Local Committees to involve the local community in their decision making process by inviting appropriate local organisations to nominate up to ten representatives to serve on the Local Committee as Community Representatives, together with Named Substitutes.
- 2.2 The Northern Area Local Committee at their meetings held on 15 January and 11 March 2004 agreed that the Depute Chief Executive/Director of Corporate Resources make such arrangements as might be necessary to facilitate the submission of outstanding nominations for Community Representatives and named Substitutes for the Northern Area Local Committee.
