The Committee noted Mr Faulds resignation and agreed to the appointment of Mrs W Campbell as the Kilmarnock Elderly Forum Representative on the Committee with Mrs A Gallagher as her substitute.

### **6.2 BELLFIELD COMMUNITY COUNCIL**

It was reported and noted that arising from the dissolution of Bellfield Community Council, Mrs Finvola Barnes and Mr James Dunsmuir would no longer be eligible to serve as Community and Substitute Representatives respectively on the Local Committee.

It was further noted that the reconstitution of the Bellfield Community Council was in hand and it was hoped that this would be completed early next year.
