MINUTES OF PREVIOUS MEETING

3. There were submitted, for information, and noted, the Minutes of the meeting of the Cumnock Area Local Committee held on 23 May 2001 (circulated).

LOCAL ISSUES

4.1 LOCAL ISSUES

There was submitted a report dated 27 August 2001 (circulated) by the Depute Chief Executive/Director of Corporate Resources which provided information on local issues raised and, where applicable, the timescale for reporting back to the Local Committee.

It was agreed:-

- (i) to request the Director of Development Services to provide a six monthly monitoring report on the regeneration of business within the Cumnock Area to a future meeting; and

7.1 DISBURSEMENT OF GRANTS 2001/2002 (Item 3.4(ix), Page 1925, 99/02)

It was reported and noted that, in accordance with the decision of the Local Committee on 20 June 2001, the Depute Chief Executive/Director of Corporate Resources had determined that the grant awards approved in principle to the undernoted organisations be amended as follows, and that as a result the total expenditure committed on community grants within the Cumnock Area for the current financial year amounted to £51,959.00, being the allocation available to the Committee for this purpose, namely:-

CHILDREN'S SERVICE PLAN 2001-2004 (Item 9, Page 1902, 99/02)
