GUIDELINES ON THE WORKING WEEK FOLLOWING THE NATIONAL AGREEMENT "A TEACHING PROFESSION FOR THE 21ST CENTURY"

2. There was submitted a report dated 23 May 2001 (circulated) by the Director of Educational and Social Services which sought approval for guidelines on the 35 hour working week for staff and teachers Conditions of Service following the national agreement "A Teaching Profession for the 21st Century" and further actions related to that agreement.

It was agreed to recommend:-

- (i) that the document detailed at Annex A of the report be used in negotiations within establishments on the 35 hour working week for the academic session 2001-2002;
- (ii) that the operation of arrangements for the 35 hour working week be monitored through the Joint Consultative Committee (Teachers);
- (iii) approval of the establishment of any subsequent negotiating structures or processes that are required as a result of documentation issued by the Scottish Negotiating Committee for Teachers; and

(iv) otherwise, to note the contents of the report.

The meeting terminated at 1138 hours.
