COMMUNITY SERVICES

OPERATION SPOTLIGHT

8. There was submitted and noted a report dated 12 March 2001 (circulated) by Chief Inspector McKnight, Strathclyde Police, which advised of "Spotlight" activity and other crime trends over the recent period.

Arising from discussion, it was agreed to request the Depute Chief Executive/Director of Corporate Resources, in consultation with Chief Inspector McKnight, to arrange for the Local Committee to inspect the CCTV system installed at a location within the Cumnock Area.

CONTROL OF DOG FOULING (Item 15, Page 2962, 96/99)

9. There was submitted a report dated 1 March 2001 (circulated) by the Director of Community Services on measures available to the Council for dealing with dog fouling.

DRAFT CHILD AND YOUNG PERSONS CHARTER OF RIGHTS

11. There was submitted a report dated 21 February 2001 (circulated) by the Director of Educational and Social Services on the history and development of East Ayrshire

Council's Draft Child and Young Person's Charter of Rights, upon which the Committee's views were sought as an essential part of the community consultation process.

It was agreed:-

- (ii) that copies of the draft Child and Young Person's Charter of Rights be provided to YIPworld.com and Lorna Phillips, School Pupil Representative on the Local Committee with a request that these be made available to young people in the local community.

A FRAMEWORK FOR MENTAL HEALTH SERVICES IN SCOTLAND: PROGRESS REPORT ON JOINT MENTAL HEALTH STRATEGIES (Item 15, Page 4105, 96/99)

12.
