1. PURPOSE OF REPORT

- 1.1** To update the Committee on the current position of community representation on the Doon Valley Local Committee during the period 1 April 2001 to 31 March 2002.

- 3.3** East Ayrshire (South) Forum on Disability have nominated Mr William Frew as Community Representative with a nomination for Named Substitute still to be submitted.
