RECRUITMENT OF COMMUNITY REPRESENTATIVES 2002/2003

Report by the Depute Chief Executive/Director of Corporate Resources

1. PURPOSE OF REPORT

- 1.1 To advise of the decision in respect of the appointment of Community Representatives of local organisations to serve on the Irvine Valley Local Committee for the period from 1 April 2002 to 31 March 2003.

2. BACKGROUND

- 2.1 The Irvine Valley Local Committee at its meeting on 6 February 2002 agreed to remit to the Depute Chief Executive/Director of Corporate Resources the initiation of the process for the submission of new nominations for Community Representatives and Named Substitutes by the relevant organisations, to serve during the period 1 April 2002 to 31 March 2003 and to make such arrangements as might be necessary to facilitate this process.
- 2.2 As members are aware, the Local Committee agreed to retain the current Community Organisation representation on the Local Committee, namely:- (a) five members from the appropriate Community Councils; (b) one member from the appropriate Elderly Forum Interest Groups; (c) one member from the Disability Forums; (d) one member from the Youth Forum (or equivalent); (e) one member from the Pre-Five Organisations in the area; and (f) one member from Crookedholm Community Association.
