RECRUITMENT OF COMMUNITY REPRESENTATIVES 2003/2004

Report by the Depute Chief Executive/Director of Corporate Resources

1. PURPOSE OF REPORT

- 1.1 To advise of the position in respect of the appointment of Community Representatives of local organisations to serve on the Irvine Valley Local Committee for the period 1 April 2003 to 31 March 2004.

2. BACKGROUND

- 2.1 The Irvine Valley Local Committee at its meeting on 5 February 2003 agreed, amongst other things, to remit to the Depute Chief Executive/ Director of Corporate Resources the initiation of the process for the submission of new nominations for Community Representatives and Named Substitutes by the relevant organisations, to serve during the period 1 April 2003 to 31 March 2004 and to make such arrangements as might be necessary to facility this process.
- 2.2 As members are aware, the Local Committee agreed to retain the current community organisation representation on the Local Committee, namely:-
- (a) five members from the appropriate Community Councils;
 - (b) one member from the appropriate Elderly Forum (or equivalent);
 - (c) one member from the Disability Forum;
 - (d) one member from the Youth Forum (or equivalent);
 - (e) one member from Crookedholm Community Association; and
 - (f) one member from Pre-Fives.

- 3.1 Nominations for Community Representatives and Named Substitutes on the Irvine Valley Local Committee for the period from 1 April 2003 to 31 March 2004 are set out in Appendix 1.
