PLAY PARK PROVISION

Report by the Director of Community Services

1. PURPOSE OF REPORT

- 1.1 To advise the Local Committee of the Council's proposals for the upgrading of play park provision across East Ayrshire and seek comments on the proposals specifically relating to the Local Committee area.

2. BACKGROUND

- 2.1 The introduction of new European Standards for play equipment and safety surfacing, changes in demand for play facilities and ageing stock of play equipment provided by the Council necessitated a review of current provision and the development of a plan for future investment in playparks. It was also felt that existing provision did not meet the aspirations of young children. The initial inspection of Council play parks was carried out by Dunlop Playground Services, an independent consultancy.
- 2.2 A cross-party member officer working group was established to examine all aspects of play park provision and make recommendations for the style, standard and location of play parks.

3. CONSIDERATIONS

- 3.1 Following discussions and site visits the Working Group recommended that over time all East Ayrshire Council play parks would be brought up to the standards required by European Standards EN1176 and EN1177.
- 3.2 Having considered the options available for safety surfacing the Working Group selected a recycled rubber grid tile surface that provides the most effective balance between cost and safety.
- 3.3 The type and range of play park provision was also discussed in detail and the Group determined that where possible separate provision should be made for toddlers, juniors and teenagers. This range of provisions will ensure maximum play value and will address health and safety issues that can arise when age groups are mixed. Teenager provision, in the form of multi-sport walls was considered to be the most appropriate type of facility for older children. The Working Group did not favour providing shelters for teenagers.

- 3.4 In examining play park provision the Working Group also looked into Skateboarding and agreed that direct provision of skateboard facilities should not take priority over play parks but that support would be offered to any group seeking to provide skateboard facilities.
- 3.5 Appendix A shows the Working Groups proposals for this local committee area, Appendix B shows the proposals for the whole of East Ayrshire. Priorities for year one (2002/03) have been put forward and have sought to concentrate on those areas which have been most affected by equipment removal. The recommendations of the Working Group were subsequently approved by the Community Services Committee as the basis for consultation.
- 3.6 In each Appendix the abbreviations used in the Provision column are as follows:-

T – Toddler Area (£15,000)
J – Junior Area (£26,000)
TS – Teenage Sportswall (£12,500)

The approximate cost of the areas is shown in brackets.

4. POLICY IMPLICATIONS

- 4.1 NIL

5. LEGAL IMPLICATIONS

- 5.1 The Council had an obligation to ensure that any play park it provides meets appropriate Health and Safety Standards ie EN1176 and EN1177.

6. FINANCIAL IMPLICATIONS

- 6.1 The proposed programme of play park refurbishment and replacement will require phased funding over several years. The Council is currently considering its capital programme for 2002/03 which will be the first year of the programme.

7. CONCLUSIONS

- 7.1 The refurbishment and replacement programme provides an effective response to the issues currently facing the Council and will substantially improve the current standard of play park provision over time.

8. RECOMMENDATIONS

- 8.1 It is recommended that the Local Committee considers the proposals for its area and puts forward any comments or suggestions for further consideration by the Council's Working Group.
