LOCAL COMMITTEE GRANTS SCHEME

LOCAL COMMITTEE GRANTS SCHEME 2001/2002

5. There was submitted a report dated 21 August 2001 (circulated) by the Depute Chief Executive/Director of Corporate Resources which outlined the financial position in respect of Community Grants for the financial year 2001/2002, together with a summary statement relative to outstanding applications for Community Grant received from local organisations.

It was further reported that updated bank balances had been received in respect of Kilmarnock Folk Club (£12.83 as at 29 June 2001), Howard Park Bowling Club (£3,712.06 as at July 2001), Springhill Place Pensioners Club (£840.57 as at 29 June 2001) and 6th Kilmarnock Girl Guide Company (£596.16 as at 6 August 2001).

It was agreed as follows:-

Declaration of Interest

Councillor Reeves declared a non pecuniary interest in the item relating to the Loudoun Musical Society and took no part in the discussion or decision.

- (b) Disability

Stroke Club Outings Travel Scheme - the Committee noted that an award of £145.16 had been made to the organisation under delegated powers by the Depute Chief Executive/Director of Corporate Resources in consultation with the Chair of the Local Committee.

- (c) Leisure

Howard Park Bowling Club - the Committee noted that an award of £300 had been made to the organisation under delegated powers by the Depute Chief Executive/Director of Corporate Resources in consultation with the Chair of the Local Committee.

In response to a request by the group, the Committee agreed that the group be permitted to delay expenditure of the grant until Spring 2002.

Gatehead Ladies Club - the Committee noted that an interim award of £250 had been made to the organisation under delegated powers by the Depute Chief Executive/Director of Corporate Resources in consultation with the Chair of the Local Committee.

It was agreed that a further award of £550 be made.

Springhill Place Pensioners Club - the Committee noted that an interim award of £400 had been made to the organisation under delegated powers by the Depute Chief Executive/Director of Corporate Resources in consultation with the Chair of the Local Committee.

It was agreed that a further award of £620 be made.

OPERATION SPOTLIGHT

6. There was submitted a report dated 17 August 2001 (circulated) by the Director of Community Services on the nature and results of "Spotlight" operations, localised crime figures and ongoing initiatives over the preceding period and which advised of forthcoming initiatives.

7. There was submitted a report dated 21 August 2001 (circulated) by the Director of Community Services which sought the nomination of a Community Representative and Substitute for membership of the East Ayrshire Community Safety Forum.

It was agreed to continue consideration of nominations to serve on the Community Safety Forum to the next meeting of the Local Committee.

DEVELOPMENT SERVICES

KILMARNOCK CYCLEWAYS AND PEDESTRIAN FACILITIES

8. There was submitted a report dated 16 August 2001 (circulated) by the Director of Development Services on proposals for the provision of cycleways and pedestrian facilities in Kilmarnock.

It was agreed:-

- (i) to endorse the provision of cycleways and pedestrian facilities proposed for the Kilmarnock Central local area;
- (ii) to note the Local Committee's concerns regarding issues of road safety in the vicinity of the retail development at Queen's Drive, Kilmarnock; and
- (iii) otherwise, to note the content of the report.

Councillor Linton left the meeting during discussion of this item.

EDUCATIONAL AND SOCIAL SERVICES

CHILDREN'S SERVICE PLAN 2001-2004

9. There was submitted a report dated 31 July 2001 (circulated) by the Director of Educational and Social Services on the completion, content and implementation of East Ayrshire Council's second Children's Service Plan, "Inspiring Young People" and which sought for the participation of Community Representatives in the planned review process.

It was agreed to continue consideration of nominations to serve on the Community Representative Forum to the next meeting of the Local Committee.

LOCAL ISSUES

10.1 LOCAL ISSUES

There was submitted a report dated 20 August 2001 (circulated) by the Depute Chief Executive/Director of Corporate Resources on local issues raised and, where applicable, the timescale for reporting back to the Local Committee.

It was agreed:-

- (i) that, in respect of the issue of the redevelopment of Kilmaronock Town Centre, including the Glencairn Square area, the Director of Development Services be invited to make a presentation to the next meeting of the Local Committee and that an invitation be extended to all Kilmaronock Central Local Committee Community Councils to attend the meeting;
- (ii) that, in respect of the issue of bus services, the Director of Development Services be asked to liaise with Strathclyde Passenger Transport Executive regarding the desirability of an improved service between the London Road area of Kilmaronock and Crosshouse, as well as the possible introduction of a service linking retail developments at Queen's Drive and Glencairn Street with the Town Centre of Kilmaronock; and
- (iii) otherwise, to note the contents of the report.

Councillor Reid left the meeting during discussion of this item.

10.2 NEW LOCAL ISSUES

The undernoted item was identified as a potential local item which could become the subject of a future report to Committee:-

- (i) Skateboarding facilities within Kilmaronock.
