MINUTES OF PREVIOUS MEETING

4. There was submitted for information and noting, the Minutes of the meeting of the Kilmarnock Central Local Committee held on 20 March 2001 (circulated).

4.1 MATTERS ARISING

4.1.1 Recruitment of Community Representatives 2001/2002

It was agreed, in respect of Items 4(ii)(b) and 4(v) respectively, to note that Knockentiber Community Council had been dissolved and, as a result, would not be represented on the Local Committee for the time being and to approve the appointment of Laura Ann Ellis as the youth representative on the Local Committee following the summer recess.

- 4.1.2 It was agreed, in respect of Item 9(ii)(a), that a Community Grant in the amount of £120 be awarded to the Gatehead Monday Club in connection with its Christmas party.

LOCAL COMMITTEE GRANTS SCHEME

LOCAL COMMITTEE GRANTS SCHEME 2001/2002

5. There was submitted a report dated 1 May 2001 (circulated) by the Depute Chief Executive/Director of Corporate Resources which outlined the financial position in respect of Community Grants for the financial year 2001/2002, together with a summary statement relative to outstanding applications for Community Grant received from local organisations.

It was agreed as follows:-

- (i) **Applications approved (for the purpose identified in the application)** viz:-
- (a) Arts and Cultural
Kilmarnock Aeolian Male Voice Choir - £112.50
- (b) Early Education and Childcare
Henderson Church Playgroup - £1,116.25 and that the group be encouraged to investigate the possibility of seeking exemption in future from the payment of VAT through charitable status.
- (c) Leisure Activities
Bonnyton Social Club - £1,500
Crosshouse Millennium Fun Day - 50% of the total expenditure to a maximum grant of £1,000, subject to the submission of a full list of expected expenditure with quotes for larger pieces of equipment.
- (d) Older People
Crosshouse Friendship Club - £150
Bonnyton Old Men's Cabin - £185
Bentinck Elderly Social Club - £177
- (e) Sport
Bonnyton Football Club - £1,270 to cover the cost of strips and goalposts only and subject to:- (i) submission of final audited accounts; and (ii) the strips belonging to the club and not to the individual, with the club agreeing not to dispose of the strips without consultation with

the Council in the event that another organisation might benefit from old strips in the future.

7.1 OPERATION SPOTLIGHT REPORT

There was submitted and noted a report dated 30 April 2001 (circulated) by the Director of Community Services which advised of the nature and results of "Spotlight" operations, localised crime figures and ongoing initiatives over the preceding six week period and which advised of forthcoming initiatives.

7.2 SAFER SCOTLAND INITIATIVE: "KNOW THE SCORE"

The Police Liaison Officer provided information to the Local Committee on a new Safer Scotland Initiative entitled "Know the Score" launched on 14 May 2001 and due to run initially until 31 August 2001 and which would provide an inter-agency approach to enforcement, education and treatment issues surrounding drug misuse.

It was agreed to note that Strathclyde Police would be available to provide awareness-raising inputs to local groups upon request and that related enquiries should be directed to the Council's Police Liaison Officer.

LOCAL ISSUES

9. There was submitted a report dated 30 April 2001 (circulated) by the Depute Chief Executive/Director of Corporate Resources on local issues raised and, where applicable, the timescale for reporting back to the Local Committee.

It was agreed to approve the submission dates of local item issues as detailed within the Appendix to the report.
