RECRUITMENT OF COMMUNITY REPRESENTATIVES 2001/2002

Report by Depute Chief Executive/Director of Corporate Resources

1. PURPOSE OF REPORT

- 1.1 To advise of current progress for the recruitment of Community Representatives for 2001/2002 and to advise of the arrangement for the submission of new nominations for community membership by the relevant organisations.

2. BACKGROUND

- 2.1 The Kilmarnock North Local Committee at its meeting on 6 February 2001, agreed, to the organisational sectors as set out in Appendix I and that one organisational sector would remain vacant subject to reconstitution of a Community Council for the Dean area and identification of an appropriate organisational body. It was also agreed to remit to the Depute Chief Executive/Director of Corporate Resources to initiate with the Secretary of the Federation of Community Groups of Kilmarnock North, the process of submission of the new nominations for Community Representatives and Named Substitutes by the relevant organisations, to serve during the period 1 April 2001 to 31 March 2002 and to make such arrangements as might be necessary to facilitate this process.

3. PRESENT POSITION

- 3.1 As in past years, the Kilmarnock North Federation of Community Groups have considered and made representations to the Local Committee on the nominations of Community Representatives for the coming year.
- 3.2 Accordingly, the Kilmarnock North Federation of Community Groups have considered potential nominations for Community Representatives and Substitutes and details of the nominations are set out in Appendix I.

4. FINANCIAL/LEGAL/POLICY IMPLICATIONS - Nil.

5. RECOMMENDATIONS

- 5.1 It is recommended that the Local Committee:-
- (i) agree to consider the submission of new nominations for community membership by the relevant organisations as notified by the Kilmarnock North Federation of Community Groups as detailed in Appendix I;

- (ii) to remit to the Depute Chief Executive/Director of Corporate Resources to make such arrangements as might be necessary to facilitate the submission of outstanding nominations for Substitute Community Representatives; and
- (iii) otherwise, to note the contents of the report.
