MINUTES OF PREVIOUS MEETING

3. There was submitted for information and noting, the Minutes of the meeting of the Kilmarnock South Local Committee held on 12 September 2001 (circulated).

3.1 MATTERS ARISING

3.1.1 Shortlees Community House, 68-70 Caprington Avenue, Shortlees

Arising from consideration of the foregoing Minutes, it was reported and noted that the ground floor of the Community House had now been partially occupied by Housing staff and that the upper floor remained vacant.

VENUES FOR FUTURE MEETINGS

LOCAL COMMITTEE GRANTS SCHEME 2001/2002

- 6. There was submitted a report dated 25 October 2001 (circulated) by the Depute Chief Executive/Director of Corporate Resources which outlined the financial position in respect of grants received for the financial year 2001/2002, together with a summary statement relevant to outstanding applications for Community Grant received from local organisations.

The Committee took the following decisions:-

- (i) **Applications Approved (for the purpose specified on the application), viz:-**

- (a) Early Education and Childcare

Bellfield After School Care - The Committee noted that an award of £415 had been made to the organisation under delegated powers by the Depute Chief Executive/Director of Corporate Resources in consultation with the Chair of the Local Committee.

Noah's Ark Creche - £555.35, subject to verifying that there were no other mats within the Shortlees Community Education Centre which the group could use.

- (b) Disability

Archway Phab Club - £773.00

Cessnock Club - to note that an award of £216.00 would be made.

- (c) Older People

Glebe Old Men's Cabin - £65.00

- (d) Young People

Bellfield Bowling Club (Junior Section) - £800.00

Murray Boys Club - £1,000.00, subject to the Club providing identification on the strips that they had been part funded by the Kilmarnock South Local Committee.

SAFER STREETS POLICING REPORT ("U" DIVISION)

7. There was submitted and noted a report dated 15 October 2001 (circulated) by the Director of Community Services on the nature and results of policing issues, operations, localised crime figures and ongoing initiatives over the preceding period and on forthcoming initiatives.

As a result of concerns raised in connection with the "Know the Score" drugs campaign and continuing problems of vandalism in Kilmarnock South, it was agreed that the Police Liaison Officer would raise the concerns expressed with the appropriate personnel.

8. There was submitted and noted a report dated 22 October 2001 (circulated) by the Director of Finance on the outcome of a review of cash collection facilities at the above Office.
