### CHILDREN'S SERVICE PLAN 2001 – 2004

#### Report by Director of Education and Social Services

#### 1.0 PURPOSE OF REPORT

- 1.1 To advise Local Committee members of the completion, content and implementation of East Ayrshire Council's second children's services plan, 'Inspiring Young People'.
- 1.2 To seek the participation of Committee representatives in the plan's review process.

#### 2.0 BACKGROUND

- 2.1 The Children (Scotland) Act 1995 placed a duty on local authorities to prepare, consult upon and publish a strategic plan outlining services to children, young people and families every three years. 'Our Children' the authority's first service plan was published in 1998. 'Inspiring Young People' is more diverse than its predecessor, focusing on universal services but clearly targeting the most vulnerable children and young people.
- 2.2 'Inspiring Young People' was approved by the authority's Policy and Resources Committee on 14 June 2001

#### 3.0 THE PLAN

- 3.1 'Inspiring Young people' covers 6 central themes:-

- Children & Young Peoples Rights
- A Good Start in Life
- Health & Wellbeing
- Learning and Development
- Children & Young People with Additional Needs
- Children & Young People Safety

And has 4 overall aims:

- to ensure children and young people increasingly have a voice in the issues which affect them
- to ensure children and young people receive appropriate support, education and services to enable them to achieve their potential, particularly those who are most vulnerable
- to promote children and young people's positive health
- to promote children and young people's safety and wellbeing

#### **4.0 CHILD AND YOUNG PERSON'S CHARTER OF RIGHTS**

4.1 East Ayrshire Council's Child and Young Person's Charter of Rights – (based on the United Nations Convention on the Rights of the Child) has been incorporated into the plan. This is a vital component in the authority's drive to promote active citizenship among its young people. The Charter seeks to balance awareness and application of rights with acknowledgement of responsibilities. Local Committee consultation concerning the Charter was undertaken in 2001.

#### **5.0 COMMUNITY PARTICIPATION**

5.1 A number of workshop forums were initiated, enabling community representatives to participate in shaping the Plan:

- The Community Representative Forum included, Elected Members; Local Committee Members; Ayrshire & Arran Health Council; School Board and East Ayrshire Childcare Partnership representation;
- A Youth Forum involving 17 young people aged 14 to 17 years;
- A voluntary sector local Service Providers Forum, involving representatives from 23 agencies;
- Children and young people from the Chinese community;
- A website questionnaire completed by 500 children and young people;
- Nursery involvement through Circle Time and questionnaire.

#### **6.0 CHILDREN'S SERVICE PLAN IMPACT ON LOCAL COMMITTEE AREA**

6.1 'Inspiring Young People' aims to provide the following benefits across East Ayrshire, some of which are subject to available resources and partnership funding.

- A commitment to promoting active citizenship with East Ayrshire's children and young people, in particular considering the establishment of Youth Councils;
- Emphasis on ensuring that children have a good start in life, by expanding childcare services
- Closer collaboration between all agencies, including the voluntary sector, particularly in relation to drugs misuse;
- Promotion of National Standards in Fostering and Adoption;
- Recruitment of additional Children's Carers;
- Enhancement and development of adoption services

6.2 Geographically specific targets include:

- Evaluation of the pilot Sitter Service in Shortlees with consideration of application for a New Opportunities Fund application for permanent project
- Development of peer education

## **7.0 IMPLEMENTATION**

- 7.1 Six multi-disciplinary groups have responsibility for implementing the plan. Each focuses on a particular area of 'Inspiring Young People' reporting to an authority led multi-agency steering group, which monitors the overall implementation of the plan
- 7.2 'Inspiring Young People' will be subject to review as an essential part of the service plan's implementation and monitoring process. It is hoped that the Community Representative Forum, comprising local committee representation will meet at least annually to review progress.
