### **LOCAL ISSUES**

#### **1. PURPOSE OF REPORT**

#### **2. BACKGROUND**

- 2.1 Community Representatives had expressed concern that there was a feeling that the Council "owned" the Agenda and that decisions appeared to have been made by the Council prior to the Local Committee meeting.
- 2.2 The Council has always intended that Community Representatives could raise issues for consideration by Local Committees and the Guide to Local Committees makes reference to this. However, the Council has accepted that there was a need to formalise the process and, as a result, a standard item was included on Local Committee Agendas inviting locally raised items for consideration at some future meeting. This practice was initiated in August 1999.

- 3.1 Detailed in the enclosed Appendix is a list of the local items which have been raised to date and the programme for reporting back to Committee on those issues not already implemented.

#### **4. CONCLUSION**
