#### **AUCHINLECK OUTDOOR BOWLING CLUB - MEN'S CENTENARY CELEBRATIONS**

##### **Report by the Depute Chief Executive/Director of Corporate Resources**

### **1. PURPOSE OF REPORT**

- 1.1** The purpose of the report is to request that the Sub-Committee consider an application from Auchinleck Outdoor Bowling Club for a contribution towards the cost of hosting a Bowling Tournament on Saturday 27 April 2002.

### **2. BACKGROUND**

- 2.1** Auchinleck Bowling Club was founded in 1902 and the Club are planning a series of events to take place during the Men's Centenary season such as fun days, open days and special invitation days.
- 2.2** The Group will host a Men's Bowling Tournament to take place on Saturday 27 April 2002 and will be followed by a dinner/hospitality. The dinner will be attended by approximately 50-60 persons comprising of members of the Club both men and women, appropriate representation of the Council and other guests.

### **3. FINANCIAL IMPLICATIONS**

- 3.1** This is the first application from Auchinleck Outdoor Bowling Club for civic hospitality. The total cost of the event is approximately £600.
- 3.2** The Club has requested a contribution of £300.

### **4. POLICY IMPLICATIONS**

- 4.1** Council policy for dealing with applications for recognition of Anniversary celebrations of local groups, establishments etc, approved by this Sub-Committee on 31 January 2001, recommends £3 x 100 = £300 for a 100th Anniversary.
