STEWARTON COAT OF ARMS COMMITTEE

Report by the Depute Chief Executive/Director of Corporate Resources

1. PURPOSE OF REPORT

- 1.1 The purpose of the report is to request that the Sub-Committee consider an application from Stewarton Coat of Arms Committee for a contribution towards the cost of a buffet lunch to take place following the presentation of the Coat of Arms on 15 June 2002.

2. BACKGROUND

- 2.1 The Stewarton Coat of Arms Committee was set up on July 2001 for the purpose of applying to the Lord Lyon King of Arms for the old Burgh of Stewarton Coat of Arms to be reinstated in, and for the benefit of, the town of Stewarton.
- 2.2 The presentation of the Letters Patent will be made by the Bute Pusuvant of Arms to Stewarton and District Community Council on 15 June 2002 prior to the Stewarton Bonnet Guild crowning of the queen ceremony.
- 2.3 Thereafter, the group have organised a buffet lunch to take place in the Institute Hall, Stewarton to be attended by approximately 26 people comprising of members of the Community Council, the Bonnet Guild, Elected Members and Officials of the Council.

3. FINANCIAL IMPLICATIONS

- 3.1 This is the first application from Stewarton Coat of Arms Committee for civic hospitality. The total cost of the event is £170 and the group are requesting a contribution of £140.

5. RECOMMENDATION

- 5.1 The Sub-Committee is asked to:-

- (i) consider the request from Stewarton Coat of Arms Committee for a contribution towards their buffet lunch and celebration of the presentation of the Coat of Arms; and
