**OPERATION SPOTLIGHT**

**Report by Director of Community Services**

**1. PURPOSE OF REPORT**

- 1.1 To advise Members of the nature and results of “Spotlight” operations, localised crime figures and ongoing initiatives over the preceding period, and to advise of forthcoming initiatives.

**2. BACKGROUND**

- 2.1 Members previously agreed to make “Spotlight” a standing item on the Committee’s agenda. To improve the local interest of this report, several topical areas of specific local interest will now be included.

**3. DISCUSSION**

**3.1 Operation Spotlight :**

- 3.1.1 **Safer Street** has been running since 1 February 2000 and between then and 31 July 2000. The following are totals for the whole of 'U' Division:

Total Persons Searched	11084
Total persons reported for possession of knives or other weapons	281
Total licensed premise visits	5010

**3.1.2 Safer Streets: Monday 24 July 2000 (Kilmarnock area)**

There was 1 person arrested for possession of a knife.			

A 50 year old male was arrested after a disturbance in a Kilmarnock park whereby he had possession of a kitchen knife. This was not in the local committee area.

### 3.1.3 Safer Streets: Wednesday 26 July 2000 (Kilmarnock area)

A 29 year old male was arrested in possession of a kitchen knife in a dwellinghouse garden. This was not in the local committee area.

### 3.2 Crime Trends (all figures relate to the Local Committee area)

3.2.2 The increase in drug related offences is due to the pro active policing methods being employed and also the quantity and quality of information being received from the public. During the period compared the number of persons charged with 'supplying offences' has increased from 0 to 10.

### 3.3 Pro Active Initiative

3.3.1 A very successful window etching day was held within the car park of Council Headquarters on Wednesday 26 July 2000. Over 50 vehicles had their registration number etched onto the windows by Autoglass, free of charge, which is a great aid to identification if the vehicle is stolen. Approximately 20 pedal cycles were also marked with their postcode by the Community Safety Department of Kilmarnock Police Office.

3.3.2 A successful bid to the Chief Constable's Community Safety Challenge Fund has resulted in 5000 information cards being printed for youngsters attending Kilmarnock Football Club matches. The cards will assist in trying to reduce anti social behaviour in and around the ground during matches. This was a joint initiative between Strathclyde Police, Kilmarnock Football Club and East Ayrshire Community Safety Forum.

3.3.3 The remainder of the bid money will be used to produce crime prevention information cards for the 'older person' in a joint initiative between Strathclyde Police, East Ayrshire Elderly Forum and East Ayrshire Community Safety Forum. It is hoped that these will be printed around the beginning of September.

3.3.4 Initial discussion have taken place with Strathclyde Police, East Ayrshire Education Department, East Ayrshire Leisure and Recreation Department and Kilmarnock Football Club regarding the production of an interactive video dealing with drug and alcohol abuse for issues to schools throughout East Ayrshire. This

is possible due to our third successful bid to Scotland Against Drugs for challenge fund finance.

3.3.5 The recent Schoolwatch Spotlight has just finished with 11 incidents of vandalism or housebreaking being reported at school premises. Of these none were in the local committee area.
