#### **RECRUITMENT OF COMMUNITY REPRESENTATIVE/NAMED SUBSTITUTES - 2000/01**

##### **Report by Depute Chief Executive/Director of Corporate Resources**

#### **1. PURPOSE OF REPORT**

- 1.1** To advise the Local Committee on the outcome of recruitment for a Youth Forum Community Representative to serve on the Northern Area Local Committee for the period 5 September 2000 to 31 March 2001 and the current position on nominations for named Substitutes.

#### **2. BACKGROUND**

- 2.1** The Council's Decentralisation Scheme makes provision for Local Committees to involve the local community in their decision-making process by inviting appropriate local organisations to nominate up to 10 representatives to serve on the Local Committee as Community Representatives, together with named Substitutes.
- 2.2** The Northern Area Local Committee at their meeting held on 27 April 2000, agreed to remit to the Director of Education to make such arrangements as might be necessary to facilitate the submission of outstanding nominations for Community Representative and named Substitute in respect of the Youth Forum and to remit to the Director of Corporate Resources to pursue nominations in respect of the remaining vacancies for named Substitutes.

#### **3. PRESENT POSITION**

- 3.1** Graham Short, Head of Schools, has advised that the nomination for Youth Forum Representative on the Northern Area Local Committee is Simon Quig, Depute Head Boy, Stewarton Academy, Stewarton. No named Substitute has been proposed.
- 3.2** To date, the Business Community and Elderly Forum organisations have not submitted nominations for named Substitutes.
