##### **Report by Depute Chief Executive/Director of Corporate Resources**

#### **1. PURPOSE OF REPORT**

- 1.1 To update the Committee on the current position of community representation (Appendix I) on the Northern Area Local Committee during the period 1 April 2001 to 31 March 2002.

#### **2. BACKGROUND**

- 2.1 The Council's Decentralisation Scheme makes provision for Local Committees to involve the local community in their decision-making process by inviting appropriate local Community Organisations to nominate up to 10 representatives to serve on the Local Committee as Community Representatives, together with named Substitutes.

#### **3. CURRENT POSITION**

- 3.1 Margaret Lees, Community Representative and David Porter, named Substitute on behalf of the Disability Forum have resigned their membership of Kilmarnock Forum on Disability, which effectively terminates the eligibility of their representative role on behalf of the Forum to the Northern Area Local Committee.
- 3.2 Kilmarnock Forum on Disability have yet to nominate successors to serve on the Northern Area Local Committee.
- 3.3 The Church Forum, Elderly Forum and Youth Forum have vacancies for named Substitutes.
