MINUTES OF PREVIOUS MEETING

1. The Minutes of the previous meeting held on 28 September 2000 (circulated) were submitted and approved as a correct record.

MATTERS ARISING

- 2.1 **Action Team Employment Initiative** - The Chair indicated that that he had written on behalf of the Strategic Partnership Group to the Secretary of State for Scotland requesting that the Action Team for Jobs initiative be extended to other areas of East Ayrshire Council which would benefit from the initiative. It was noted that a copy of the response would be circulated to members of the Strategic partnership Group.
- 2.2 **East Ayrshire Strategy for Youth** - Trainee Destinations - Noted that a breakdown of the final destinations of the 16 trainees who had embarked upon the programme had been provided to Matt Donnelly, Community Representative.

EAST AYRSHIRE'S SOCIAL INCLUSION IMPLEMENTATION ARRANGEMENTS: PROPOSALS FOR CHANGE

3. There was submitted a report dated 3 November 2000 (circulated) by the Chief Executive of East Ayrshire Council which requested the partnership consider the proposed changes in more detail and indicated how and when the proposed changes would be made.

It was agreed:-

- (i) to approve the decision making arrangements for Social Inclusion as detailed in the report;
- (ii) to request that partner members identify nominations to the Northern Area SIP Board and the Coalfield Area SIP Board and notify the Chief Executive of East Ayrshire Council by 30 November 2000;
- (iii) that Ayrshire and Arran Health Board be added to the membership of the Executive Group and that the Depute Chief Executive/Director of Corporate Resources of East Ayrshire Council be appointed as Chair; and
- (iv) otherwise to endorse the revised implementation arrangements for securing Social Inclusion.

WORKING TOGETHER: LEARNING TOGETHER

4. The Social Inclusion Manager, East Ayrshire Council reported and it was agreed that partner organisations representing the Coalfield Area SIP submit their nominations to the Social Inclusion Manager by the 30 November 2000.

SOCIAL INCLUSION CHALLENGE FUND - YOUTH OUTREACH PROPOSAL - CATRINE

5. There was submitted (circulated) report dated 30 October 2000 by the Depute Chief Executive/Director of Corporate resources of East Ayrshire Council which sought the endorsement for non-recurring revenue funding from the Social Inclusion Challenge Fund to support an outreach youth project in the Catrine area.

It was agreed to endorse the funding bid to the Social Inclusion Challenge Fund for £1,300 to deliver the Outreach Youth project in Catrine.

ADDITIONAL INVESTMENT TO AYRSHIRE AND ARRAN HEALTH BOARD

6. The Health Promotion Specialist, Ayrshire and Arran Health Board reported that £800,000 to £900,000 had been allocated to the Health Board per annum for a 4 year period to target Health inequalities and which also embraced Social Inclusion initiatives.

It was agreed to welcome the funding initiative and to request that the Executive Group consider identifying projects with a Social Inclusion emphasis which would meet the funding criteria.
