COMMUNITY GRANTS SCHEME

GRANTS TO LOCAL ORGANISATIONS: COMMUNITY GRANTS (Item 3.2, Page 3428)

- 1.1 There was submitted a report dated 11 June 1998 (circulated) by the Director of Support Services which summarised the pertinent information relevant to an application for Community Grant by a local organisation in respect of financial year 1998/99.

The Committee considered the undernoted application and took the following decision.

DEVELOPMENT AT CRAGSIDE VIEW, SOUTHCRAIGS, KILMARNOCK
