Aims and objectives of the organisation

The aim of West Netherton Bowling Club is to promote the game of outdoor bowls and provide recreational and social facilities for the members.

2 Purpose of the grant (including breakdown of costs)

A grant of £56,858 has been requested to refurbish the bowling club located on West Netherton Street, Kilmarnock.

The bowling club building is run down and in need of major refurbishment. The grant will be used to totally refurbish the existing toilets (including new walls, ceilings and floor), install a disabled toilet, new plumbing, heating and associated electrical works, new doors, levelling of uneven flooring and general decoration to the entrance and toilet areas. The creation of a disabled toilet requires the relocation of the ladies toilet and a revised layout to the clubhouse. As the building is an old brick build the scale of works required is reflected in the project costs.

Recent issues with the roof of the clubhouse have also impacted on the deterioration of the interior of the building. The club have advised that emergency roof repairs have been undertaken and the clubhouse is now watertight. The cost of repairs was $\pounds3,624$ and a further $\pounds6,697$ was recently spent on the purchase of a new John Deere mower to help improve the green's playing surface.

The project will be supported by an application for £10,000 to Awards for All.

The bowling club is used regularly by The Royal British Legion, the Kilmarnock blind club, a local mental health group and by the community for affordable functions.

The proposed works will significantly improve the facilities for all members of the community who use the facility but more specifically for the less abled members and visitors.

The bowling club operates a bar facility and the profits are used to support the annual running costs of the bowling club.
