#### **COUNCIL ELECTIONS - 6 MAY 1999**

1. There was submitted and noted a report dated 10 May 1999 (circulated) by the Chief Executive which provided the results of the recent Council Elections held on Thursday 6 May 1999 as shown in Appendix I to these Minutes.

#### PROVOST/DEPUTE PROVOST

#### 2.1 ELECTION OF PROVOST

The Chief Executive invited nominations for Provost.

Councillor McIntyre, seconded by Councillor Jackson moved that Councillor Boyd be elected as Provost.

Councillor Reid, seconded by Councillor McDill moved as an amendment that Councillor Faulds be elected as Provost.

On a division by a show of hands the motion was carried by 18 votes to 11 and Councillor Boyd was elected as Provost and his investiture then took place.

Provost Boyd then took the Chair.

#### 2.2 ELECTION OF DEPUTE PROVOST

Provost Boyd invited nominations for Depute Provost.

Councillor McIntyre seconded by Councillor Jackson moved that Councillor Darnbrough be elected as Depute Provost.

Councillor Reid, seconded by Councillor Wilson moved as an amendment that Councillor Stevenson be elected as Depute Provost.

On a division by a show of hands the motion was carried by 18 votes to 12 and Councillor Darnbrough was elected as Depute Provost and her investiture then took place.

#### LEADER/DEPUTE LEADER OF THE COUNCIL

#### 3.1 ELECTION OF LEADER

Provost Boyd invited nominations for Leader of the Council.

Councillor Farrell, seconded by Councillor Kelly moved that Councillor McIntyre be elected as Leader of the Council.

Councillor Wilson, seconded by Councillor Linton moved as an amendment that Councillor Reid be elected as Leader of the Council.

On a division by a show of hands the motion was carried by 18 votes to 12 and Councillor McIntyre was elected Leader of the Council.

#### 3.2 ELECTION OF DEPUTE LEADER

Provost Boyd invited nominations for Depute Leader of the Council.

Councillor Farrell, seconded by Councillor Kelly moved that Councillor Jackson be elected as Depute Leader of the Council.

Councillor Reid, seconded by Councillor McDill moved as an amendment that Councillor Wilson be elected as Depute Leader of the Council.

On a division by a show of hands the motion was carried by 18 votes to 12 and Councillor Jackson was elected as Depute Leader of the Council.

#### **PREVIOUS MINUTES**

**4.** There were submitted and approved as a correct record, Minutes of meeting of Council held on 30 April 1999 (circulated).

#### **MEETING ARRANGEMENTS**

5. There was submitted a revised updated report dated 10 May 1999 (circulated) by the Director of Corporate Services which (i) presented for information of Council, details of existing Committee/Sub-Committee and Member/Officer Group structure and membership numbers; (ii) requested Council to consider, following Council Elections, new Committee etc membership, Chair and Vice-Chair details; and (iii) sought approval of the Meetings Calendar covering meetings cycle from 24 May to 30 June 1999.

It was noted that the suggestions contained in the report were made in the context of the existing structure operated by the former Council, pending receipt of guidance from CoSLA on Local Authority decision making processes and structures. This would be forthcoming following consideration by the Scottish Parliament of Report of the Independent Commission on Local Government, at which point any proposals for review of Committee structures would be brought before Council for consideration.

Thereafter, it was agreed that the membership number of the main Committees remain 20, split 11 Labour Members, 8 SNP Members and 1 Scottish Conservative

and Unionist Member, that the Leisure Sub-Committee and the Decentralisation Sub-Committees be deleted from the structure and that the remaining revised membership compositions, split and quorum suggestions as detailed in the report, (with the exception of the Special <u>Ad Hoc</u> Commercial Strategy Review Committee) be approved.

Membership details and Chair and Vice-Chair proposals for each Committee/Sub-Committee, Forums and Member/Officer Working Group were intimated individually and considered as follows:-

#### (i) <u>Committees/Sub-Committees</u>

It was agreed:-

- (a) to appoint the Members to the related Committee/Sub-Committees as detailed in Appendix II;
- (b) to appoint Chair and Vice-Chairs as appropriate to the related Committees/Sub-Committees as detailed in Appendix II; and
- (c) that as only two further meetings of the Special <u>Ad Hoc</u> Commercial Strategy Review Committee were scheduled prior to the summer recess and that thereafter there would be a review of existing Committee responsibilities to determine an appropriate monitoring regime for the various commercial business units that had been established, to amend the existing membership formula of the Committee (which required <u>ex officio</u> appointments) and appoint the following Members of Council who had been members of the Committee prior to the Council elections, namely; Councillors McIntyre, Macrae, Darnbrough and Jackson and also to appoint Councillors Reid, Wilson and McLean.

### (ii) Social Inclusion Group and Equal Opportunity Forums

Councillor McIntyre, seconded by Councillor Jackson moved that as the Council, in meeting its commitment to address issues of Social Inclusion, had established an East Ayrshire Social Inclusion Partnership Strategy Group and also a series of Equal Opportunity Forums to develop and progress for the Council an Equal Opportunities Strategy, then in order to carry through these important initiatives in a co-ordinated manner, a single Chair be appointed who had responsibility for the Social Inclusion Partnership Strategy Group and all of the Equal Opportunity Forums detailed in the report. He further moved that the Chair of Social Inclusion and Equal Opportunity be the Vice-Chair of the Housing Committee and, as a result of additional responsibilities and in recognition of the importance the Council placed on the success of these initiatives, that the Vice-Chair responsibility allowance be made up to that of a full Chair's.

Councillor Reid seconded by Councillor McDill moved that the status quo remain.

On a division by a show of hands the motion was carried by 18 votes to 12.

Thereafter it was agreed to appoint the remaining Members to the Group and Forums as detailed in Appendix II.

### (iii) Local Committees and Local Planning Committees

It was noted that the associated member composition of the Local Committees and Local Planning Committees had been agreed, as detailed in Appendix II.

**6.1** There was submitted a report dated 5 May 1999 (circulated) by the Director of Corporate Services which requested Council to consider various Member appointments as the Council's representatives to outside organisations.

It was agreed:-

(i) having considered appointments to each organisation individually and following the related motions and amendments as recorded below to appoint Members to outside organisations, as detailed in Appendix IV:-

### (a) Coalfield Communities Campaign

Councillor Farrell, seconded by Councillor Jackson moved to appoint Councillors Kelly and Farrell.

Councillor Reid, seconded by Councillor Wilson moved as an amendment that Councillor Faulds be appointed as one of the Council's representatives.

On a division by a show of hands, the motion was carried by 18 votes to 12.

#### (b) Cumnock and Doon Valley Minerals Trust

Councillor Farrell, seconded by Councillor Jackson moved to appoint Councillors Kelly, Carmichael, Taylor and Farrell.

Councillor Reid, seconded by Councillor Wilson, moved as an amendment that Councillor Faulds be appointed as one of the four Council representatives.

Councillor Campbell requested that the vote be taken by roll call and following a show of hands in which 12 Members supported the request, in accordance with Standing Order 35, there being at least one third of Members present objecting to the vote being taken by a show of hands, the vote was taken by roll call and the voting was as follows:-

The motion was carried by 17 votes to 13.

#### (c) Cumnock and Doon Valley Victim Support Group

Councillor Farrell, seconded by Councillor Jackson moved to appoint Councillor Carmichael.

Councillor Reid seconded by Councillor Wilson moved as an amendment to appoint Councillor Faulds.

On a division by a show of hands the motion was carried by 18 votes to 12.

#### (d) East Ayrshire Business Partnership Ltd

Councillor Farrell, seconded by Councillor Jackson moved to appoint the Chair of Development Services Committee, Councillor McIntyre and Councillor Jackson.

Councillor Reid, seconded by Councillor Linton moved as an amendment that in order to reflect the political balance of the Council Councillor Reid be appointed as one of the 3 Council representatives.

On a division by a show of hands the motion was carried by 18 votes to 12.

- (ii) that it be remitted to the relevant Service Directors to obtain the necessary information (outlined in paragraph 5.1 of the report) and to advise the Chief Executive accordingly; and
- (iii) that on receipt of appropriate returns from the relevant Service Departments the Chief Executive submit a report to a future meeting of Council confirming the details of the duly taken up appointments.

#### 6.2 MEMBERSHIP OF LICENSING BOARD

There was submitted a report dated 22 April 1999 (circulated) by the Solicitor to Council which advised the Council on the legal requirement of East Ayrshire Licensing Board and which sought to have Members appointed to serve on the Board.

Having heard the Solicitor to the Council who recommended that the Council should proceed to elect 11 Members to serve on the Licensing Board, the following Members were appointed:-

Provost Boyd and Councillors Macrae, Kelly, Knapp, Smith, Ross, D Coffey, Wilson, Linton, MacLean and Stevenson.

#### 6.3 SCOTTISH ENVIRONMENT PROTECTION AGENCY (SEPA)

There was submitted a report dated 23 March 1999 (circulated) by the Director of Community Services to consider a request from the Clerk to the Board of the Scottish Environment Protection Agency West Region to submit a nomination for a member of the Council to serve on the West Region Board of the Scottish Environment Protection Agency.

It was agreed:-

- (i) to nominate the Chair of Community Services Committee to the West Region Board of the Scottish Environment Protection Agency; and
- (ii) to remit to the Director of Community Services to liaise with the nominated Member with a view to submitting nominations to SEPA by 11 June 1999.

### APPOINTMENT OF <u>EX OFFICIO</u> JUSTICES OF THE PEACE

7. There was submitted a report dated 19 April 1999 (circulated) by the Solicitor to the Council which advised the Council of the right to appoint Elected Members as <u>ex</u> officio Justices of the Peace, the criteria applied in respect of such appointments and some of the duties involved.

It was agreed to renominate the Members who had previously held <u>ex</u> <u>officio</u> JP appointments namely, Councillors Farrell, Jackson, D Coffey and McDill and to nominate four others, names to be submitted to the Solicitor to the Council before 21 May 1999 for consideration by Council.

#### TRAINING FOR NEWLY ELECTED MEMBERS

8. There was submitted a report dated 7 May 1999 (circulated) by the Director of Corporate Services which proposed induction training for newly Elected Members of the Council following the Elections on 6 May 1999 and to outline a broad structure for a more detailed training programme to be provided prior to the recess.

It was agreed:-

- (i) to approve the arrangements for and the content of the induction training for newly Elected Members outlined in paragraph 3 of the report;
- (ii) to approve the timetable for the Committee/Departmental responsibilities briefings set out in paragraph 4.3 of the report and note the broad objectives of these briefings specified in paragraph 4.2 of the report;
- (iii) to approve the approach proposed for corporate policy and procedure briefings as outlined in paragraph 5 of the report;
- (iv) to approve the proposed approach to further training specified in paragraph 6 of the report;
- (v) that all training arrangements be remitted to the Director of Corporate Services in consultation with appropriate Officers; and
- (vi) otherwise, to note the contents of the report.

#### KIRKIN' OF THE COUNCIL - 23 MAY 1999

**9.** There was submitted a report dated 27 April 1999 (circulated) by the Director of Corporate Services which advised Council of proposed arrangements for the annual Kirkin' of the Council ceremony and which sought formal approval for same.

It was agreed:-

- (i) that the invitation to visit Laigh Kirk, Kilmarnock be formally accepted and that the Service be ecumenical in nature;
- (ii) that the usual practice be maintained of making a donation to help meet the costs of any afternoon hospitality provided by the Church following the Service up to a maximum of £200; and
- (iii) that the detailed arrangements be remitted to the Director of Corporate Services in consultation with the Provost.

The meeting terminated at 1142 hours.
